William Henry 'Krom' Hendricks was the first sportsman to be formally barred from representing South Africa on the basis of race. Hailing from Cape Town's Bo-Kaap, he played in 1892 for the South African Malay team against the touring English, who insisted that he was among the best fast bowlers in the world. This made his exclusion from South Africa's tour of England in 1894 and subsequent Test series all the more unjust.

Ranged against Hendricks were virulent racism and a political alliance between arch-imperialist Cecil John Rhodes, Afrikaner Bond leader J.H. Hofmeyr, and cricket administrator William Milton. *Too Black to Wear Whites* documents Hendricks's tireless struggle for recognition and the public controversies around his exclusion. The book shows how Hendricks was further sidelined at senior club level by a cricket establishment determined to save its white players the embarrassment of being shown up by the country's best fast bowler.

Considering his importance in South African sports history, surprisingly little is known about Krom Hendricks. The story of his life is told here for the first time in a fascinating drama that describes the formation of a segregated South Africa through the career of an exceptional cricketer who challenged the boundaries of the system.

In the 1990s, deep-cover police agent RS536 took on the Durban underworld as part of a new organised crime intelligence unit. He rubbed shoulders with drug lords, smugglers and corrupt cops, and was instrumental in busting an international drug ring and foiling a bank heist, among many other dangerous engagements.

But then, as the country's new democracy birthed a struggle between the old and the new guard in the South African Police Service, his identity and his life

came under threat. In this action-packed account, Johann van Loggerenberg describes how, as a young policeman, he worked closely with the investigative team of the Goldstone Commission to uncover the 'third force' – apartheid security forces that supplied weapons to the Inkatha Freedom Party to destabilise the country.

He also delves into how and why, at the height of state capture at the South African Revenue Service in 2014, he was falsely accused of being an apartheid spy, a lie that persists up to today. Here, finally, is the truth behind deep-cover police agent RS536.

Whistleblowers are seldom seen as heroes. Instead, they are often viewed through a negative lens, described as troublemakers, disloyal employees, traitors, snitches and, in South Africa, as impimpis or informers. They risk denigration and scorn, not to mention dismissal from their positions and finding their careers in tatters.

With corruption and fraud endemic in democratic South Africa, whistleblowers have played a pivotal role in bringing wrongdoing to light. They have provided an invaluable service to society through disclosures about cover-ups, malfeasance and wrongdoing. Their courageous acts have resulted in the recovery of millions of rands to the fiscus and to their fellow citizens as well as improved transparency and accountability for office bearers and politicians. Some would argue it was whistleblowing that brought down a president and the corrupt 'state capture' regime.

But in most cases, the outcomes for the whistleblowers themselves are harrowing and devastating. Some have been gunned down in orchestrated assassinations, others have been threatened and targeted in sinister dirty-tricks campaigns. Many are hounded out of their jobs, ostracised and victimised. They struggle to find employment and are pushed to the fringes of society. Where there is litigation, this drags on and on through the courts. Mental health and relationships suffer. The psychological burden of choosing

to speak up when there has been little reward or compensation is a heavy one to carry.

The Whistleblowers shines a light on their plight, advocating for a change in legislation, organisational support and social attitudes in order to embolden more potential whistleblowers to have the courage to step up. Corruption cost taxpayers around R1.5 trillion during Jacob Zuma's spell as president of South Africa. Despite attempts by the police, the courts and the Public Protector to stem the rising tide of graft in South Africa, several politicians were rewarded with high office after stealing the aspirations of millions of people.

Fred Daniel, one citizen among many targeted by predator politicians, stood up against the scourge. The retaliation he faced after attempts by corrupt politicians to grab his nature reserve in Mpumalanga included vandalism, arson, smears and death threats. His nemesis is Deputy President D.D. Mabuza, who presided over several departments in the province that were wrecked by graft before he ascended to the position of the second most powerful politician in the country. Fred has won more than twenty cases over the past fifteen years in magistrates' and high courts where his claims of corruption-related harassment were found credible. At great personal cost, Fred and his family stood up to corruption. They endured the loss of a livelihood and their home – and the fear that follows when the government places a target on the back of a citizen blowing the whistle on its misdeeds. Now, in *My Only Story*, Deon tells the full story of the sexual abuse he suffered at the hands of 'Jimmy,' the once brilliant teacher and later media luminary who led a sinister and predatory double life. Deon's mission to expose his abuser takes him from the perpetrator's high-school years at an agricultural school to his eventual arrest in Hartenbos in the Western Cape. Deon follows the trail from the highly regarded Grey College and Paul Roos Gymnasium to media titan Naspers. In the process, he devises a model that anyone can use to identify pedophiles in their midst. In Deon's own words: "It's nice to pretend that men don't rape children, but once you know what to look for, it becomes surprisingly easy to spot them. Once you match a universal pattern with a specific man's profile, what once was hidden becomes obvious." *My Only Story* is a riveting account of one man's struggle to overcome childhood trauma, to help others who might face the same ordeal, and to bring his abuser to justice.

On 1 October, 1990 a group of armed rebellion invaded Rwanda from Uganda. The group was quick to be identified as the Rwandan refugees who decided to come back home by the barrel of the gun. After almost 4 years of bitter fighting and negotiations with the Rwandan government, the war culminated into a genocide committed between April and July 1994. As a result, more than one million of Rwandans, mostly from Tutsi ethnic group, were savagely killed while up to three millions of mostly Hutu ran en masse into exile in neighbouring countries. I was one of them. While many refugees were forced to return to Rwanda from their refugee camps in Tanzania and Zaire, I trekked down the continent in search of both protection and greener pastures. This book narrates the where, the what and the how of major experiences of my journey from the minute I left my remote village in Rwanda in June 1994 until I settled down in South Africa in 1999 to start a new life. It also highlights the multifaceted obstacles that refugees and immigrants are faced with in adapting to a complete new and harsh environment.

Deneys Schreiner was one of an illustrious family that produced a worldfamous author (his great-aunt Olive); a prime minister of the Cape Colony (his grandfather, W.P, who also defended a Zulu prince against specious charges in a colonial court); and Appellate Justice O.D. Schreiner, his father, who fought against National Party efforts to remove coloured people from the common voters' roll. Deneys was an academic, a scientist and a man of strong liberal principles, with a good sense of humour and widespread interests in the sciences, arts and public affairs. These qualities enabled him, in his quiet, steady way, to transform what was then the University of Natal and the society around it. Between the 1960s and 1980s, he supported and initiated several important endeavours to promote constitutional futures other than those imposed by the apartheid government. One of the most significant of these was the Buthelezi Commission, which he chaired. This biography sets out the contexts of Deneys's forebears, his youth, wartime service, studies in Britain and America, family life, and tenure as vice principal, as well as the context of the times in which he lived. It is based on extensive archival research, supported by interviews with family members, former colleagues, friends and journalists. The picture that emerges is of a man who made a great contribution to the struggle for democracy in South Africa. And then there is the story of his beard, once described as a potent symbol of his presence and implacable integrity.

The Unlikely Mr Rogue is the story of the quiet man behind the so-called 'rogue unit' at SARS, who has become a lightning rod for so many in politics today. It takes the reader on a journey – Ivan's growing up in Merebank, KZN, his politicisation, his friendship with Pravin Gordhan and his running of Operation Vula from Lusaka, reporting to Oliver Tambo. In some ways, the

setting up of SARS was Operation Vula revisited. Many of the same operatives were now working for a higher purpose. And this higher purpose, of providing the money to reduce inequality in the state, was a daily mantra for Gordhan, Pillay and others. They really believed in it.

Groenink tells of the early 1990s in Lusaka, of their falling in love, of the insecurity in coming back to the country, and the times when Ivan was in charge of stationery in the bowels of Shell House. This is the story of a good man, an unlikely man, a quiet man, determined to use SARS to fund the post-liberation nation-building, and his downfall at the hands of his enemies and a scurrilous Sunday Times.

Lionel Wulfsohn's Golden Years is a nostalgic reflection of a life growing up in the platteland dorp of Rustenburg at the beginning of the Twentieth Century. The story starts with a historical description of the author's forebears, before presenting a series of childhood and adolescent memories. These serve to capture the closeness of family life and the freedom of skinny-dipping in the mountain pools of Magaliesberg. Other sketches include: a bitterly fought general election; transport in the 1290s; and a sprinkling of salty characters, such as veterans of both the Anglo-Boer War and the British Colonial era, and a German-Jewish air ace from World War One. The book ends with a detailed account of the author's own experience at the Battle of Monte Stanco in World War Two.

Taken altogether, the book is an enchanting mix of anecdote and bittersweet humour, presenting the essence of Rustenberg between the wars and the author's own powerful moment of destiny in war-torn Italy. http://www.marymartin.com/web?pid=747240

Papwa Sewgolum, against all odds, won the Dutch Open playing in only his second 'white' tournament, and a total of three times in four attempts. Then after being allowed to play in the Natal Open, he demolished a top field, BUT was presented with his trophy in the rain while the others players watched from the clubhouse igniting a worldwide backlash leading to South Africa being banned from the Olympics, whilst Papwa became the symbol of the antiapartheid sport movement. Again allowed to play in the Natal Open he beat the world number 1, Gary Player, head-to-head, only for the apartheid government, after a failed assassination attempt, to ban him from all tournaments in South Africa, and then withhold his passport to prevent him playing abroad. This book is written in a popular, conversational style. It's easily understood by those who don't know much about golf, yet the book's message is of hope and perseverance and in so doing, creates a black golfing hero to inspire the youth.

A memoir like no other – Claudine Shiels and her sister Lisa van der Merwe have brought South Africa's oldest sexual abuse case to court. The sisters used the Frankel 8 Criminal Procedures decision to bring court action against their sexually abusive step-uncles forty years later – this is their story. On a hot summer evening in 1967, eight-year-old Claudine Brown watched from the back seat of a car stalled on a railway track in the suburbs of Cape Town, as a fast-moving train hurtled towards them. Her mother sat frozen with fear in the driver's seat. The events leading up to this moment were unremarkable, giving no clue to their catastrophic timing. The aftermath was

brutal and childhood-wrecking, leaving Claudine and her younger sister Lisa world-weary before they had even got started.

When her mother, unraveled by post-traumatic shock, abandoned the family, and her father reached for the nearest comfort to ease his pain – a new wife – Claudine had only one defense against the years of exploitation and physical, emotional and sexual abuse that followed: hope. She remembered what normal life was, and plotted her course back there.

Dr Abdullah Abdurahman (1872–1940) was the first person of colour ever to be elected to political office in South Africa. He represented some of the poorest people in Cape Town on the City Council and then the Provincial Council. First winning a seat in 1904, he was to serve the city for 36 years. Beloved by the people of District Six, for whom he fought so hard, Dr Abdurahman is a forgotten giant of the fight for justice.

The grandson of slaves, he trained as a doctor in Scotland, returning to the Cape with a Scottish wife. Nellie and he were powerful partners – and their daughter, Cissie Gool, was among the most important political figures of her generation. Dr Abdurahman led the African Political Organisation – the leading coloured party of this period. He was a friend and ally of key political figures of his time: Sol Plaatje, Walter Rubusana, Mahatma Gandhi and W.P. Schreiner. He was a leading advocate of black unity, working tirelessly to resist the onslaught of white racism.

The doctor was among the most internationally admired South Africans of his generation, arguing his case on delegations to London and India. He led South African Indians to Delhi, confronted the Viceroy and made a memorable address to the Indian National Congress. At his death in 1940 Cape Town ground to a halt as the entire community paid their respects. Drawing on previously undiscovered material, this biography lifts Dr Abdurahman from the obscurity into which he has so unjustly sunk –

explaining his life against the background of the difficult times in which he lived.

In Autopsy he covers the hard lessons learnt as a rookie pathologist, as well as some of the most unusual cases he's encountered.

During his career, for example, he has dealt with high-profile deaths, mass disasters, death by lightning and people killed by African wildlife. Blumenthal takes the reader behind the scenes at the mortuary, describing a typical autopsy and the instruments of the trade. He also shares a few trade secrets, like how to establish when a suicide is more likely to be a homicide. Even though they cannot speak, the dead have a lot to say – and Blumenthal is there to listen.

Why do we need to communicate science? Is science, with its highly specialised language and its arcane methods, too distant to be understood by the public? For example, the availability of medical knowledge on the internet and the immense opportunities to inform oneself about health risks via social media are undermined by the manipulable nature of this technology that does not allow its users to distinguish between credible content and misinformation. In countries around the world, scientists, policy-makers and the public have high hopes for science communication: that it may elevate its populations educationally, that it may raise the level of sound decision-making for people in their daily lives, and that it may contribute to innovation and economic well-being. This collection of current reflections gives an insight into the issues that have to be addressed by research to reach these noble goals, for South Africa and by South Africans in particular.

Post-apartheid South Africa continues to face challenges in its attempts at economic transformation for the benefit of the majority of the people, who were marginalised under decades of apartheid and colonisation. This need for transformation has resulted in various policy initiatives, including the ongoing demands for the nationalisation of the economy. The commercial media has a central role in shaping policy debates. But this media is an ideological tool as much as it is an economic resource since it is owned and controlled by people with political and economic interests. It therefore tends to support and promote the interests of the owners.

This book provides a Marxist critique of the representation of the nationalisation of the mines debate by the South African commercial media. Radebe examines corporate control of the media in order to articulate the interrelations between the state, capital and the media, and the way the commercial media represents, shapes and influences public policy. He concludes that beyond factors such as ownership, commercialisation and the influence of advertising on news content, the global capitalist hegemony has a more powerful influence on the commercial media in South Africa than previously thought.

South Africa is a rapidly urbanising society. Over 60% of the population lives in urban areas and this will rise to more than 70% by 2030. However, it is also a society with a long history of labour migration, rural home-making and urban economic and residential insecurity. Thus, while the formal institutional systems of migrant labour and the hated pass laws were dismantled after apartheid, a large portion of the South African population remains double-rooted in the sense that they have an urban place of residence and access to a rural homestead to which they periodically return and often eventually retire. This reality, which continues to have profound impacts on social cohesion, family life, gender relations, household investment, settlement dynamic and political identity formation, is the main focus of this book.

Migrant Labour after Apartheid focuses on internal migrants and migration, rather than cross border migration into South Africa. It cautions against a linear narrative of change and urban transition.

The book is divided into two parts. The first half investigates urbanisation processes from the perspective of internal migration. Several of the chapters make use of recently available survey data collected in a national longitudinal study to describe patterns and trends in labour migration, the economic returns to migration, and the links between the migration of adults and the often-ignored migration of children. The last three chapters of this section shine a spotlight on conditions of migrant workers in destination areas by focusing on Marikana and mining on the platinum belt. The second half of the book explores the double rootedness of migrants through the lens of the rural hinterland from which migration often occurs. The chapters here focus on the Eastern Cape as a case study of a region from which (particularly longer-distance) labour migration has been very common.

The contributions describe the limited opportunities for livelihood strategies in the countryside, which encourage outmigration, but also note the

This is despite concepts such as Africanisation, indigenisation and decolonisation of the curriculum having become buzzwords, especially after the #MustFall campaigns, student-led protests from 2015.

This book argues that, beyond the use of internally constructed strategies to foster curriculum transformation in South Africa, it is important to draw lessons from the curriculum transformation efforts of other African countries and African-American studies in the United States (US).

The end of colonialism in Africa from the 1950s marked the most important era in curriculum transformation efforts in African higher education, evident in the rise of leading decolonial schools: the Ibadan School of History, the Dar es Salaam School of Political Economy and the Dakar School of Culture. These centres used rigorous research methods such as nationalist historiography and oral sources to challenge Eurocentric epistemologies. African-American studies emerged in the US from the 1920s to debunk notions of white superiority and challenge racist ideas and structures in international relations. The two important schools of this scholarship were the Atlanta School of Sociology and the Howard School of International Affairs.

Jan Geldenhuys was called up in October 1899 to serve in the Kroonstad Commando under Commandant Martinus Schoeman on the Western Front and deployed for the Siege of Kimberley. He fought at the Battles of Belmont, Graspan, Twee-Riviere (Modder River), Magersfontein and several other minor skirmishes. He was captured in April 1902 [a mere two months before the end of the war] and banished as a prisoner of war to Umballa, India, where his experiences till Thursday, 20th November 1902, were documented. He shared a tent with his father-in-law and later met up with his father and brother who were POW's at Bhimtal. His diaries, written in high-Dutch, are lodged with the Anglo-Boer War museum in Bloemfontein. The author's grandmother, Lizzie Preller, having published her "Oorlogsherinneringe", provided the motivation and inspiration to research and to add this addition to African history. Jan Geldenhuys and Lizzie Preller were buried on Rustpan, the family farm between Bothaville and Kroonstad in the Orange Free State. The author followed his grandfather and father's footsteps and joined the military - serving as a pilot for the duration of the Rhodesian War. Like his grandparents, he has published his war experiences. John Dovey of Just Done Productions Publishing designed the cover and published the book through Pinetown Printers in KZN Natal, in 2009. This edition is all my own work and includes many New Zealanders, mainly from the early Contingents, who fought and died during the Boer War - known as the South African War in New Zealand. This updated and revised edition will thus appeal to anyone interested in military history, especially conflicts in Southern Africa and New Zealand.

The violence left thousands of people dead, injured, homeless and emotionally wounded. This book provides a historical study of the origins, causes and nature of political violence in the rural community of KwaShange in the Vulindlela district. This was one of the areas most affected by the political violence in the Natal Midlands, but it has been the subject of only patchy and partial investigation. Mxolisi Mchunu threads individual and local factors with regional and national forces and, through a local study, explains to great effect the political violence that rocked parts of Natal in that period. The account offers the testimony of survivors and the effect of the violence on community members

in the ensuing years. One central contention is that the influence of the violence was transmitted across generations and sexes, through whole families and communities. Hegel is most often mentioned - and not without good reason - as one of the paradigmatic exponents of Eurocentrism and racism in Western philosophy. But his thought also played a crucial and formative role in the work of one of the iconic thinkers of the 'decolonial turn', Frantz Fanon. This would be

inexplicable if it were not for the much-quoted 'lord-bondsman' dialectic - frequently referred to as the 'master-slave dialectic' - described in Hegel's Phenomenology of Spirit. Fanon takes up this dialectic negatively in contexts of violence-riven (post-) slavery and colonialism; yet in works such as Black Skin, White Masks and The Wretched of the Earth he upholds a Hegelian-inspired vision of freedom. The essays in this collection offer close readings of Hegel's text, and of responses to it in the work of twentieth-century philosophers, that highlight the entangled history of the translations, transpositions and transformations of Hegel in the work of Fanon, and more generally in colonial, postcolonial and decolonial contexts.

As we enter the third decade of the twenty-first century, South Africa continues to function under the oppressive burden - felt directly as such by all but the elite - of three continuities from apartheid: race thinking, capitalism and the politics of tradition. Yet, as Gerhard Mare argues, continuities in the politics of tradition cannot be understood as separable from the other two, nor from the intimate metapolitics of patriarchy. incumbency' may sound cliched, this book brings it to life through an analysis of the greed of a political leadership without scruples and the rapacious impact of procurement-based capitalist class formation. The rot originates in ANC structures - akin to suicidal conduct, even after electoral defeat. Ndletyana's canvass may be local; but the lessons are universal. The book is as much about the past as it is about future. -Joel Netshitenzhe, Executive Director and Board Vice-Chairperson of the Mapungubwe Institute for Strategic Reflection (MISTRA) South Africa's governing party, the African National Congress (ANC), has undergone dramatic changes over the last thirty years. Historically a hotbed of political activism, Port Elizabeth is an illuminating site. In 2016, observers greeted with shock the ANC's loss of the city, one of its crown jewels and a party stronghold. Yet, as this book shows through its analysis of power and politics in Port Elizabeth, the party's political decline was authored by its own hand. This book studies the ANC at a local level over a 28-year period and informs what is now playing out at a national level. The book traces four stages that characterise the party's post-1990 life in Port Elizabeth: rebuilding; ascension to political office; political decline; and adaptation to new contexts where its power was lost or is under threat. Ironically, the efforts to rebuild the ANC post-unbanning lie at the root of the decline, because they were misdirected. Buoyed to office by their party's heroic stature, the book shows how some party leaders in Port Elizabeth abused power for financial gain. A generally weak regulatory environment allowed abuse to become endemic. Service delivery failed, and corrosion of moral leadership set in. As the party failed to stem the morass, internal democracy gave way to a strongman syndrome and the party deteriorated into an instrument that provided access to, and dispensed, patronage. Stunningly, electoral loss did not trigger reforms. As the ANC battled to re-make itself outside of government, some leaders even recruited the underworld to settle contests and secure access to patronage. Port Elizabeth did not see a 'new dawn'. This evidence-based book is an enthralling account of how the ANC rebuilt itself into a governing organisation, but failed to cohere into an institution of democracy, becoming instead an amalgam of competing factions for patronage. Readers will judge how much Port Elizabeth is a microcosm of the entire ANC.

The most inclusive and critical treatment to date of Mafeje as a thinker and researcher, it does not aim to be a biography, but rather offers an analysis of his overall scholarship and his role as a theoretician of liberation and revolution in Africa. Bongani Nyoka argues that Mafeje's superb scholarship developed out of both his experience as an oppressed black person and his early political education. These, merged with his university training, turned him into a formidable cutting-edge intellectual force. Nyoka begins with an evaluation of Mafeje's critique of the social sciences; his focus then shifts to Mafeje's work on land and agrarian issues in sub-Saharan Africa, before finally dealing with his work on revolutionary theory and politics. By bringing Mafeje's work to the fore, Nyoka engages in an act of knowledge decolonisation, thus making a unique contribution to South studies in sociology, history and politics.

Becoming Men is the story of 32 boys from Alexandra, one of Johannesburg's largest townships, over a period of twelve seminal years in which they negotiate manhood and masculinity. Psychologist and academic Malose Langa has documented graphically what it means to be a young black man in contemporary South Africa. The boys discuss a range of topics including the impact of absent fathers, relationships with mothers, siblings and girls, school violence, academic performance, homophobia, gangsterism, unemployment and, in one case, prison life. Dominant themes that emerge are deep ambivalence, self-doubt and hesitation in the boys' approaches to alternative masculinities that are non-violent, non-sexist and non-risk-taking. The difficulties of negotiating the multiple voices of masculinity are exposed as many of the boys appear simultaneously to comply with and oppose the prevalent norms.

Providing a rich interpretation of how emotional processes affect black adolescent boys, Langa suggests interventions and services to support and assist them, especially in reducing the high-risk behaviours generally associated with hegemonic masculinity. This is essential reading for students, researchers and scholars of gender studies who wish to understand manhood and masculinity in South Africa. While the book can be seen as a study of a place and a community, the lives of individual people and how they are embedded in the larger matrix of culture, history and the political economy are also present. Albeit whispered about rather than shouted out in the open, Khoisan belonging was meaningful on the streets and taken to heart by many street people. This book searches for answers why. Colonisation, assimilation and acculturation did not make the Khoisan disappear. Self-naming have carried resilience here, as in other places where indigenous identities have been muted and esoteric. While focusing on the Khoisan, this book includes a juxtaposition between Khoisan experiences with glimpses of the indigenous Coastal Sami's history from the author's home ground in Norway. As people built places of worship and newborn friendships reached across fences and staircases, soccer became the game of choice. Rudimentary pitches were marked out, cool drinks staked and the game unfolded with a mixture of delicate touches and bruising tackles. By the early 1970s, Wentworth's ability to spawn soccer talent, headlined by the glamorous Leeds United, grew into the stuff of legend.
