In *Healing the Exposed Being*, Robert Thornton presents a new vocabulary and ontology for understanding fundamental concepts of a regional version of the Ngoma cult, found throughout the Bantu language-speaking areas of Africa. He is thus able to provide a more integrated anthropological account of beliefs and practices that have survived from pre-colonial to postcolonial times, describing them in their own terms rather than presenting them as a reflex of modernity or reaction to colonialism, or as a consequence of neoliberalism or other social, political, economic or historical factors.

Bungoma, the knowledge and practice of ‘traditional healing’ in eastern Mpumalanga, is built on the fundamental premise that all persons are exposed to each other and to other person-like agents, including ancestors and witches, among others. This mutual and inescapable exposure is the condition for the possibility of healing, but also ultimately the cause of all illness, misfortune and death. Against this, the sangoma as healer attempts to augment the self of the exposed being through protective magic and by exposing relations between tangible (living human) and intangible (spiritual) agents or persons. Bungoma comprises multiple modalities including trance, music and rhythm, divination, herbal lore, teaching and learning, craftsmanship and healing. The aim of

Bungoma is to enable patients to heal themselves by transforming their personal narratives of self.

Thornton brings this local anthropology and its therapeutic applications into relation with global academic anthropology by exploring it through political, economic, interpretive and ecological environmentalist lenses.

THE OWL HOUSE is a visionary outsider art environment unlike any other.

Located in the small village of Nieu Bethesda in the isolated South African Karoo, what was once the childhood home of Helen Martins was transformed into a work of uncommon originality. During her lifetime, Helen was misunderstood and was widely regarded as being 'crazy'.

Living in seclusion on a meagre pension, she created the Owl House in the face of much adversity. Lacking any formal art training and using materials readily at hand – recycled glass bottles, builders cement, mirrors and wire – she created what is now internationally regarded as an outsider art environment of outstanding interest. Assisted by helpers – chiefly Koos Malgas who under her supervision built many of the statues in her sculpture yard – she spent more than twenty-five years creating the Owl House, increasing the complexity and density of the work by a slow process of accretion. All the while living there, she transformed the house and yard into a symbolically rich world of wonder, infused with her quirky humour, personal yearnings and mystical insights. Today, the Owl House remains a powerful testimony to the triumph of perseverance and imagination.

The surprisingly high rate of supermarket patronage in low-income areas of Windhoek, Namibia's capital and largest city, is at odds with conventional wisdom that supermarkets in African cities are primarily patronized by middle and high-income residents and therefore target their neighbourhoods. What is happening in Namibia and other Southern African countries that make supermarkets so much more accessible to the urban poor? What are they buying at supermarkets and how frequently

do they shop there? Further, what is the impact of supermarket expansion on informal food vendors? This report, which presents the findings from the South African Supermarkets in Growing African Cities project research in 2016-2017 in Windhoek, looks at the evidence and tries to answer these questions and others. The research and policy debate on the relationship between the supermarket revolution and food security is also discussed. Here, the issues include whether supermarket supply chains and procurement practices mitigate rural food insecurity through providing new market opportunities for smallholder farmers; the impact of supermarkets on the food security and consumption patterns of residents of African cities; and the relationship between supermarket expansion and governance of the food system, particularly at the local level.

The wide-ranging essays in this sixth volume of the New South African Review demonstrate how the consequences of inequality extend throughout society and the political economy, crippling the quest for social justice, polarising the politics, skewing economic outcomes and bringing devastating environmental consequences in their wake. The transition from apartheid to the post-apartheid era has highlighted questions about the past and the persistence of its influence in present-day South Africa. This is particularly so in education, where the past continues to play a decisive role in relation to inequality. *Between Worlds: German Missionaries and the Transition from Mission to Bantu Education in South Africa* scrutinises the experience of a hitherto unexplored German mission society, probing the complexities and paradoxes of social change in education. It raises challenging questions about the nature of mission education legacies. Linda Chisholm shows that the transition from mission to Bantu Education was far from seamless. Instead, past and present interpenetrated one another, with resistance and compliance cohabiting in a complex new social order. At the same time as missionaries complied with the new Bantu Education dictates, they sought to secure a role for themselves in the face of demands of local communities for secular state controlled education. When the latter was implemented in a perverted form from the mid-1950s, one of its tools was textbooks in local languages developed by mission societies as part of a transnational project, with African participation. Introduced under the guise of expunging European control, Bantu Education merely served to reinforce such control. The response of local communities was an attempt to domesticate - and master - the 'foreign' body of the mission so as to create access to a larger world. This book focuses on the ensuing struggle, fought on many fronts, including medium of instruction and textbook content, with concomitant sub-texts relating to gender roles and sexuality. South Africa's educational history is to this day informed by networks of people and ideas crossing geographic and racial boundaries. The colonial legacy has inevitably involved cultural mixing and hybridisation - with, paradoxically, parallel pleas for purity. Chisholm explores how these ideas found expression in colliding and coalescing worlds, one African, the other European, caught between mission and apartheid education.

Writing the Ancestral River is an illuminating biography of the Kowie River in the Eastern Cape. This tidal river runs through a formative meeting ground of peoples who have shaped South Africa's history: Khoikhoi herders, Xhosa pastoralists, Dutch trekboers and British settlers. Their direct descendants in the area still interact in ways that have been decisively shaped by their shared history.



This is also a natural history of the river and its catchment area, where dinosaurs once roamed and cycads still grow. The natural world of the Kowie has felt the effects of human settlement, most strikingly through the development of a harbour at the mouth of the river in the 19th century and a marina in the late 20th century, which have had a decisive and deleterious impact on the Kowie.

People are increasingly reconnecting with nature and justice through rivers. Acknowledging the past, and the inter-generational, racialised privileges, damages and denials it established and perpetuates, is necessary for any shared future. By focusing on this 'little' river, the book raises larger questions about colonialism, capitalism, 'development' and ecology, and asks us to consider the connections between social and environmental injustice.

South African history has been punctuated by some remarkable speeches, such as Nelson Mandela's powerful and courageous statement from the dock during the Rivonia Trial, or, on the other side of the spectrum, P.W. Botha's infamous Rubicon speech, which failed to deliver anticipated reforms and intensified the conflict of the 1980s. Who can forget F.W. de Klerk's speech announcing the unbanning of the ANC and the imminent release of Mandela and other prisoners, or Mandela's speech on the Grand Parade a few days later?

Speeches that Shaped South Africa is the first collection of these historic moments and it examines about 35 speeches from the beginning of apartheid to the present day. The book includes Harold Macmillan's 'Wind of Change', Thabo Mbeki's 'I am an African', Ahmed Kathrada's speech at Nelson Mandela's funeral, and Mmusi Maimane's 'Broken Man' speech. Also included are Steve Biko, Helen Suzman, Winnie Mandela, Oliver Tambo and Julius Malema. Before and after each speech is a narrative that places it in a historical context, explains who the speaker was, and explores the effects and reception of the speech.

This is a fascinating account of South African history over the past seventy years, through the lens of important figures making significant public statements.

This latest contribution to The Road to Democracy series deftly analyses commemorations and memorialisations of the 1976 uprisings in Soweto. Voices of authorities, police and veterans of the struggle are shared through collective memories, eyewitness accounts, and oral history testimonies. These voices, and the experiences of activists, participants and observers of the uprisings, provide readers with a palpable and arresting 'truth' more compelling than that of a dispassionate history text. This volume, the seventh in the series, postulates that history is about change at a given time: while pursuing a fragile balance between partisanship and objectivity, history is open to continuous reassessment and reappraisal, revision and re-examination, construction and reconstruction.

This volume, rooted as it is in primary evidence and archival material, rather than in abstract theories, offers readers rare insights from the voices and sometimes piecemeal memories of the students, parents and authorities who lived through those turbulent and momentous days.

The Khoesan were the first people in Africa to undergo the full rigours of European colonisation. By the early nineteenth century, they had largely been brought under colonial rule, dispossessed of their land and stock, and forced to work as labourers for farmers of European descent.

Nevertheless, a portion of them were able to regain a degree of freedom and maintain their independence by taking refuge in the mission stations of the Western and Eastern Cape, most notably in the Kat River valley. For much of the nineteenth century, these Khoesan people kept up a steady commentary on, and intervention in, the course of politics in the Cape Colony.

Through petitions, speeches at meetings, letters to the newspapers and correspondence between themselves, the Cape Khoesan articulated a continuous critique of the oppressions of colonialism, always stressing the need for equality before the law, as well as their opposition to attempts to limit their freedom of movement through vagrancy legislation and related measures. This was accompanied by a well-grounded distrust, in particular, of the British settlers of the Eastern Cape and a concomitant hope, rarely realised, in the benevolence of the British government in London. Comprising 98 of these texts, *These Oppressions Won't Cease* – an utterance expressed by Willem Uithaalder, commander of Khoe rebel forces in the war of 1850-3 – contains the essential documents of Khoesan political thought in the nineteenth century.

These texts of the Khoesan provide a history of resistance to colonial oppression which has largely faded from view. Robert Ross, the eminent historian of precolonial South Africa, brings back their voices from the annals of the archive, voices which were formative in the establishment of black nationalism in South Africa, but which have long been silenced.

He boldly argues that the philosophical problem of personal identity is central to the rationale of reincarnation. This very irrationality in African thought raises our understanding of the constitution of a person.

The re-emergence of debates on the decolonisation of knowledge has revived interest in the National Question, which began over a century ago and remains unresolved. Tensions that were suppressed and hidden in the past are now being openly debated. Despite this, the goal of one united nation living prosperously under a constitutional democracy remains elusive. This edited volume examines the way in which various strands of left thought have addressed the National Question, especially during the apartheid years, and goes on to discuss its relevance for South Africa today and in the future. Instead of imposing a particular understanding of the National Question, the editors identified a number of political traditions and allowed contributors the freedom to define the question as they believed appropriate – in other words, to explain what they thought was the Unresolved National Question. This has resulted in a rich tapestry of interweaving perceptions. The volume is structured in two parts. The first examines four foundational traditions: Marxism-Leninism (the Colonialism of a Special Type thesis); the Congress tradition; the Trotskyist tradition; and Africanism. The second part explores the various shifts in the debate from the 1960s onwards, and includes chapters on Afrikaner nationalism, ethnic issues, black consciousness, feminism, workerism and constitutionalism. The editors hope that by revisiting the debates not popularly known among the scholarly mainstream, this volume will become a catalyst for an enriched debate on our identity and our future.

There is a current revival of Black Consciousness in South Africa, as political and student movements – as well as academics and campaigners working in decolonisation – reconfigure the continued struggle for socio-economic revolution with this ideology at the forefront.

Black Consciousness is also increasingly finding solidarity with similar movements around the world, in particular #BlackLivesMatter in the United States and the black power campaign gaining momentum around the memory of the Mangrove Nine in the United Kingdom. Yet there is still not enough known about the history of Black Consciousness in South Africa, nor its particular solidarity in other parts of the world.

Finding itself at the centre of decolonisation debates and renewed struggles for socio-economic power in the year of the 40th anniversary of Biko's murder, *The Black Consciousness Reader* is an essential collection of history, interviews and opinions about the philosophy being revived to finally bring revolution to South Africa. This would be not so much a violent overthrow as a deep change to a nation's thinking to properly acknowledge its Blackness, and through that its entire past, a broader sweep of its heroes and a wider understanding of its intellectual and political influences. Although Biko would be the most influential personality throughout this history, the book intends to trace the history of Black Consciousness in South Africa also through its other primary personalities and events in politics – predominantly black and woman power – as well as art and music.

Steve Biko, Onkgopotse Tiro, Deborah Matshoba, Don Mattera, Neville Alexander, Florence Ribeiro, the Black Power solidarity movement, Rick Turner, Strini Moodley, the lyrical work of Lefifi Tladi and Dashiki are among the many subjects included in this important work.

The revolutionary and psychiatrist Frantz Fanon was a foundational figure in postcolonial and decolonial thought and practice, yet his psychiatric work still has only been studied peripherally. That is in part because most of his psychiatric writings have remained untranslated. With a focus on Fanon's key psychiatry texts, *Frantz Fanon, Psychiatry and Politics* considers Fanon's psychiatric writings as materials anticipating as well as accompanying Fanon's better known works, written between 1952 and 1961 (*Black Skin, White Masks*; *A Dying Colonialism*, *Toward the African Revolution*, *The Wretched of the Earth*). Both clinical and political, they draw on another notion of psychiatry that intersects history, ethnology, philosophy, and psychoanalysis. The authors argue that Fanon's work inaugurates a critical ethnopsychiatry based on a new concept of culture (anchored to historical events, particular situations, and lived experience) and on the relationship between the psychological and the cultural. Thus, Gibson and Beneduce contend that Fanon's psychiatric writings also express Fanon's wish, as he puts it in *The Wretched of the Earth*, to "develop a new way of thinking, not only for us but for humanity."
