"Queer Bodies in African Films makes two overarching interventions. First, the book focuses on how queer bodies in films are texts. As sites invested with multiple and often overlapping discourses and narratives, queer bodies in films textualise silenced narratives and histories. They are inscribed with more than just desire, eroticism and sexuality. Second, this book sets out to read selected queer films from North Africa against and together with some from sub-Saharan Africa. It brings into productive conversation these broad regions of the continent, which in African Studies, are often demarcated along linguistic and geographic lines. This makes it possible to demonstrate how queer bodies, in their multiplicity, are disruptive figures whose materiality calls for a rethinking of how gender and sexual identities are not just performed and staged but also constructed and embodied. In examining diverse films in various languages and from different parts of the African continent, Queer Bodies in African Films shows that queer African experiences and cultural productions have developed beyond the hegemony of South Africa. Furthermore, its nuanced reading of films from different geographic zones and time frames contends that a focus on the body allows for a unique understanding of what queerness is and means within the context of Africa."

This is the seventh edition of the Compendium of key human rights documents of the African Union updated to June 2022. It is the first edition published since the untimely passing of Prof Christof Heyns who approached me many years ago with the idea for this

Compendium. The Compendium was first published in 2005 and thereafter regularly updated.

This compendium contains documents on human rights adopted under the auspices of the African Union (AU) and its predecessor, the Organization of African Unity (OAU), including documents adopted by the African Commission on Human and Peoples' Rights, the African Court on Human and Peoples' Rights and the African Committee on the Rights and Welfare of the Child. Since the sixth edition of this Compendium was published in 2016 there has been several normative developments but due to space reasons only a small number of the key new documents have been included in this edition.

Due to space constraints only extracts are reprinted of many of the documents. This compendium is by no means comprehensive but includes some key documents of relevance for students of the African human rights system and others interested in its functioning. Extracts from documents related to the New Partnership for Africa's Development (NEPAD) and the African Peer Review Mechanism (APRM) reprinted in previous editions of this compendium have been left out of this edition.

The story is told with insight and depth by Irina Filatova and Apollon Davidson, who have had a decades long association researching and writing on Russian and South African politics and history. This insightful work follows the often surprising twists and turns of the history of South Africa's relationship with Russia and its people which started in the eighteenth century and is still very much alive today. It is unfortunate that the idea that Africa contributes to international law, and has always done so, remains (in 2022) largely a side note, an auxiliary approach, rather than

something widely accepted and deeply entrenched. It is cause for pause that this is also true in Africa itself. Exploring African approaches to international law: Essays in honour of Kéba Mbaye is a volume of essays that aims to contribute to a larger effort of imagining what possible approaches to international law Africa has adopted in the decades since the 1960s. It also recognises the legacy of the great Senegalese jurist Kéba Mbaye. Edited by Frans Viljoen, Humphrey Sipalla and Foluso Adegalu, the volume is divided into five broad thematic parts, and comprises eleven chapters. It covers the following themes: 'Kéba Mbaye in African approaches to international law', 'international legal theory', 'international human rights law', 'international environmental and criminal law' and 'teaching of international law'.

This publication finds its origins in the 2017 Roundtable on African approaches to international law, held at the Centre for Human Rights, University of Pretoria. The explorations at the Roundtable on the concept of an 'African approach' to international law were taken further at the Kéba Mbaye Conference on African approaches to international law, held at the Senate Hall, University of Pretoria, in December 2018. This conference brought together around 80 students, academics, and members of civil society to address the many questions left unanswered by the death of Judge Mbaye, arguably Africa's greatest international law jurist of his generation. It provided a forum to continue discussions on 'African approaches to international (human rights) law', building on but rethinking and 'vernacularising' the Third World Approaches to International Law (TWAIL) approach. The contributions to this publication flow from papers presented at the conference. However, the reflections in the book extend beyond Kéba Mbaye as central figure. The result is a broad treatment of various aspects of African approaches to international law by thirteen authors (and co-authors), covering a wide range of generational, geographic and thematic backgrounds and perspectives.

When the Zimbabwean government imposed the 75% local content policy in 2001, young people began dominating the music scene, marking a dramatic turn in the history of Zimbabwean music and entertainment. Doreen Rumbidzai Tivenga's Music and Urban Youth Identities: A study of ghetto youth identities in contemporary culture and politics in Zimbabwe traces how the stipulation of the local content quota coincided with the post-2000 political and economic crises in Zimbabwe that pushed youth, especially those from low-income backgrounds – the 'ghetto youth' – to the margins of the country's economy. The author shows how the youth responded to this predicament by embracing the new turn in Zimbabwean music, turning to music to try to eke out a living, and at the same time articulate their daily struggles, survival strategies and aspirations. She also highlights that music is an important marker of identity and a means through which youth connect and identify with their peers, and musicians with their fans, arguing that music intersects with different ways youth construct and assert their identities, which they define in light of their local experiences as well as the demands of the globalised shifting world. Tivenga however

observes that the youth do not construct their identities in a uniform or linear way, but in complex and heterogeneous ways characterised by spatial attachments and affiliations, group affiliations, gender dynamics and a quest for visibility and power.

Zimbabwe's agrarian history has attracted robust scholarly attention over time. Much of it has, however, focused on encounters between white settler farmers and Africans over control of resources. Scholars have also focused on how the postcolonial state has undermined the country's agricultural sector through unsound policy interventions, notably the chaotic land reform programme of 2000. In both cases, emphasis is placed on the role of the state, either colonial or postcolonial, in propping up or undermining the country's agro-based economy. While this is an indispensable approach, Politics, profits, and protection: Zimbabwe's tobacco industry since 1947 provides an alternative yet complementary way of looking at the development of agriculture in Zimbabwe. The book uses the case of Zimbabwe's tobacco industry to situate white settler agriculture in the broader context of post-Second World War British imperial policy and, to an extent, American foreign economic policy, decolonisation, and global tobacco trade politics. It concludes by highlighting policy continuities and discontinuities across the colonial-postcolonial divide. By pursuing these matters, the book makes a significant contribution to Zimbabwe's economic history and to the growing literature on settler-colonial and postcolonial studies, with broader implications for regional and international trade debates. To achieve this, it draws on an extensive coverage of archives in Zimbabwe and South Africa, coupled with relevant newspaper reports, interviews, and industry publications.

Beyond Monuments: The politics and poetics of memory in post-war northern Uganda explores themes of war and peace, displacement and return, and remembering and forgetting, depicted as experiences of survivors of mass violence in the northern Uganda civil wars between 1987 and 2006. Presented as dichotomies marking key transitional moments negotiated by NGOs, governments, and post-war communities in northern Uganda, the analysis of these themes emphasises how ordinary survivors of war make claims – through oral performances, memoirs, reminiscences, and place and personal

names – that foreground memories threatened with amnesia, resulting from state and NGO driven commemorations.

Beyond Monuments shows the intersection between literature and material arts and, as a result, stylistically it shifts focus from conventional literature, defined in the genre of novels, plays, essays and short stories, to include non-inscribed or thinly inscribed texts such as cenotaphs, sculptures, statues, and other concrete objects used in the making of memory. Beyond Monuments – which shapes debates in the subjects of transitional justice, conflict management, resilience, recovery, and peace – will find a wide audience, ranging from teachers of literature and scholars of the fine arts to memory anthropologists, cultural historians, humanitarian agencies, government officials, social workers, and readers interested in the intellectual histories of neglected societies.

A reader by Atangcho N Akonumbo explores the current debates and conflicts pertaining to intellectual property (IP), trade and access to medicines in Africa as a public health issue, in a public health context. The Reader has a broad focus running across fourteen chapters. It examines the complex web of access to medicines, while introducing major concepts pertaining to access to medicines such as IP, trade, medicine and human rights, and provides a historical overview of the nexus between IP and human rights. It establishes the link between human rights, IP and access to medicines within the context of developing countries broadly and Africa in particular. The Reader discusses key flexibilities within the international IP framework championed by the TRIPS Agreement to enhance access to medicines, including compulsory licensing and parallel importation, while addressing impediments therein which provoked the Doha Declaration and arrangements thereafter. Also, it examines issues such as the implications of data exclusivity and linkage techniques; the role of anti-counterfeiting and competition laws in checking the effect of IP regimes; current threats to access to medicines at the international, regional and national levels such

as the influence of regional or bilateral trade agreements; and research and development in respect of medicines for neglected and (re)emerging infectious diseases. It discusses the contributions of naturopathic and traditional medicines as parallel and complementary systems to modern medicine in the access to medicines landscape in the African context. The Reader further addresses the implications of the difficulty of access to medicines for women, children and other social minorities such as disabled persons and Lesbian, Gay, Bisexual, and Transgender (LGBT) persons.

This Reader comes at a critical time, and potentially, a turning point in the history of public health crisis in Africa – when concerns about access to medicines have been heightened in the face of (re)emerging diseases and today the Covid-19 pandemic – a situation which has revealed gross lapses in public health governance. It is written in a simple language, making its content accessible to a wide audience. It contains informative and useful graphs, text boxes and illustrative excerpts from various primary and secondary sources. The Reader is likely to become an invaluable tool for a wide range of persons and institutions, including academics, students, legal practitioners, health professionals, drug procurement agencies, civil society organisations and the public at large, involved or interested in the access to medicines discourse.
