Over the last forty years, our vision of Chinese culture and history has been transformed by the discovery of the role of religion in Chinese state-making and in local society. The Daoist religion, in particular, long despised as "superstitious", has recovered its place as "the native higher religion." But while the Chinese state tried from the fifth century on to construct an orthodoxy based on Confucianism, Daoism, and Buddhism, local society everywhere carved out for itself its own geomantically defined space and organized itself around local festivals in honor of gods of its own choosing—gods who were often invented and then represented by illiterate mediums. Looking at China from the point of view of elite or popular culture therefore produces very different results.

John Lagerwey has done extensive fieldwork on local society and its festivals. This book represents a first attempt to use this new research to integrate top-down and bottom-up views of Chinese society, culture, and history. It should be of interest to a wide range of China specialists, students of religion and popular culture, as well as participants in the ongoing interdisciplinary dialogue between historians and anthropologists.

De Jiao ("Teaching of Virtue") is a China-born religious movement, based on spirit-writing and rooted in the tradition of the "halls for good deeds," which emerged in Chaozhou during the Sino-Japanese war. The book relates the fascinating process of its spread throughout

Southeast Asia in the 1950s, and, more recently, from Thailand and Malaysia to post-Maoist China and the global world.

Through a richly-documented multi-site ethnography of De Jiao congregations in the PRC, Hong Kong, Singapore, Malaysia, and Thailand, Bernard Formoso offers valuable insights into the adaptation of Overseas Chinese to sharply contrasted national polities, and the projective identity they build with relation to China. De Jiao is of special interest with regard to its organization and strategies which strongly reflect the managerial habits and entrepreneurial ethos of the Overseas Chinese businessmen. It has also built original bonding with symbols of the Chinese civilization whose greatness it claims to champion from the periphery. Accordingly, a central theme of the study is the role that such a religious movement may play to promote new forms of identification with the motherland as substitutes for loosened genealogical links. The book also offers a comprehensive interpretation of the contemporary practice of fu ji spirit-writing, and reconsiders the relation between unity and diversity in Chinese

The Buddha's nirvana marks the end of the life of a great spiritual figure and the beginning of Buddhism as a world religion. *Surviving Nirvana* is the first book in the English language to examine how this historic moment was represented and received in the visual culture of China. It is also a study about a pictorial image that has been in use for over 1,500 years. Mining a selection of well-documented and well-preserved examples from the sixth to twelfth centuries, Sonya Lee offers a reassessment of medieval Chinese Buddhism by focusing on practices of devotion and image-making that were inspired by the Buddha's "complete extinction." The nirvana image, comprised of a reclining Buddha and a mourning audience, was central to defining the local meanings of the nirvana moment in different

times and places. The motif's many guises, whether on a stone stele, inside a pagoda crypt, or as a painted mural in a cave temple, were the product of social interactions, religious institutions, and artistic practices prevalent in a given historical context. They were also cogent responses to the fundamental anxiety about the absence of the Buddha and the prospect of one's salvation. By reinventing the nirvana image to address its own needs, each community of patrons, makers, and viewers sought to recast the Buddha's "death" into an allegory of survival that was charged with local pride and contemporary relevance. Exhaustively researched, this study engages methods and debates from the fields of art history, religion, archaeology, architecture, and East Asian history that are relevant to both scholars and students alike. The many examples analyzed in the book offer well-defined local contexts to discuss broader historical and theoretical issues concerning representation, patronage, religion and politics, family values, and vision.

The fifteenth century is an enigma in Southeast Asian history - too late for classical inscriptions, and generally too early for indigenous texts or European observations. The arrival of European ships, ideas and economies in the early sixteenth century has long been seen as the origin of the early modern era in Southeast Asia, but the present collection challenges this view, suggesting that intense and lasting political and economic changes were already well underway by 1500.

The argument rests on developments such as the introduction of firearms, more intensive rice agriculture, Thai and Viet ceramic exports, Korean and Ryukyu contacts with Southeast Asia, the demise of Champa, the climax of Viet and northern Tai statecraft, the birth of the Melayu-Muslim kingship in Melaka and the creation of a new Muslim Javanese civilization on Java's north coast. Coincident with these changes, Ming China's engagement with Southeast Asia grew as a result of overland expansion into the Tai and Viet polities, state-sponsored maritime voyages, and private Chinese trade and migration to the region.

Southeast Asia in the Fifteenth Century: The China Factor draws together the great changes that occurred in Southeast Asia during the fifteenth century, and considers the extent to which Ming China's engagement with the region helped usher in the early modern period of Southeast Asian history.

Apart from the letters written by Hu Shih and his family members, this book also includes letters written by famous scholars and important figures at that time, such as Jiang Menglin and Fu Sinian. The English letters were mostly from the years when he was ambassador to the United States, which , from another angle, tell us something about hhis communication with western scholars and his strenuous effort to support China's war against Japan.

These ballad-stories, in contrast to past plays dating from the same period, present abuse of power and corruption as endemic in the courts and bureaucratic service, and show Judge Bao imposing the rule of law even on the emperor.
