Building on the pioneering work of Oswald Siren and James Cahill, Susan Bush's investigations of painting done under the Chin dynasty confirmed the dominance of scholar-artists in the north and their gradual development of scholarly painting traditions, and a related study of Northern Sung writings showed that their theory was shaped as much by the views of their social class as by their artistic aims. Bush's perspective on Sung scholars' art and theory helps explain the emergence of literati painting as the main artistic tradition in Yuan times. Social history thus served to supplement an understanding of the evolution of artistic styles.

In this pioneering study, Sheilah Hamilton shows that, from the earliest days of British rule, the colonial administration introduced harsh legislation to control Chinese watchmen who were employed to protect the fledgling colony's property in the absence of an effective public police force. She examines the growth in different Hong Kong Government departments of what would now be regarded as 'hybrid' police and argues that the existence of such posts within the civil service resulted in greater social control of the local Chinese community at minimal extra expense.

Amongst the topics of private security explored are: the impact of the few private security personnel engaged by local Chinese organizations such as the Nam Pak Hong, Tung Wah Hospital and Po Leung Kuk; the evolution of the District Watch Force from a force engaged in purely local security duties to an arm of the Hong Kong Government involved in non-security matters such as controversial sanitary inspections; and the unique system of village guards and scouts in the New Territories. While it shared much in common with other home and dominion universities and had to deal with the same problems that plagued higher education elsewhere in the world at the time, it also had a very distinctive role to play as an instrument of British cultural imperialism in China. From its founding in 1911 it was intended as a 'British lighthouse in the Orient' with a broad remit to educate the new generation of Chinese youth who would lead the modernisation of China. This book evaluates the success of that mission and also demonstrates the important contribution that HKU made to the development of both Hong Kong and Malaya, the two areas whence most of its students were drawn. As the first university to be established in Hong Kong, the early decades of the University's history represents the foundation of the whole higher education system in Hong Kong, a system which now boasts a larger percentage of world-ranked institutions than any other country in the world. The book has much to say about both colonial education and Hong Kong in general, and it tracks the fortunes of the colony from the peak of the British Empire's power to the destructive effects of the Japanese occupation between 1941 and 1945.

Journalists are always taught to cover the news, and not become the news. On April 21, 2005, Straits Times correspondent Ching Cheong broke that rule: he crossed the border into Shenzhen to investigate a manuscript of the memoirs of the late Chinese leader, Zhao Ziyang. That was the start of his nightmare. The next day, he was detained in isolation for more than three months, as the Public Security Bureau tried all manner of ways short of physical violence to get him to confess to spying for Taiwan. He was later "tried" in a Beijing court, his 20,000word so-called "confession" the only evidence the State Prosecutor produced, and was summarily convicted of spying for "foreign powers" and sentenced to five years' jail. His book re-counts in detail the emotional turmoil he felt at being "betrayed" by his desire to see China and Taiwan peacefully reunified, the tortuous circumstances under which he was compelled to write a "confession" of his alleged crime, and his struggle to come to terms with what he albeit unwittingly – brought upon himself. He decided to write it "to contribute in a small way to wiping out the soil that produces such miscarriages of justice" in China, to make sure that he "had not gone to jail for nothing". For the international legions of human rights activists, Ching's Ordeal describes, in very ordinary terms, how the Chinese authorities — or any other undemocratic regime — use "logic" and forms of mental torture to obtain "confessions". It shows up, without drama, the huge distance China needs to cover to become a country where the rule of law is not subject to politics. Most of all, it shows the "patriots" in the Chinese diaspora the gradient they have to walk to separate communist dictates from a culture of which there is much to be proud. Ching puts it simply: "I hope through the recounting of my story to bring attention to the situation of China's judicial system, so that we can together build a country that respects and protects the rights of a quarter of the world's population." http://www.marymartin.com/web?pid=146736

Sino-Japanese relations have been on the mend since Shinzo Abe assumed the

Japanese Prime Minister's office in September 2006. His visit to China in October 2006 and the reciprocal visits of Chinese Prime Minister Wen Jiabao in April 2007, and President Hu Jintao in May 2008, facilitated the further thawing of bilateral relations under the framework of "mutually beneficial relationship based on common strategic relationship." A substantial number of additional events have indicated the continuation of the positive trend in the strengthening of the bilateral relations.

However, several issues continue to obstruct the building of long-term confidence between the two Asian giants. Despite the overall improved relations, there is very little structural thinking about how to move the Sino-Japanese relations to the next level and how to institutionalize security dialogues at the regional and international level.

This book provides an overview of the current situation and also gives suggestions on what is needed to move beyond the haphazard level of cooperation in Northeast Asia, especially as the six-party talks seem to have broken down. This book is the third study done by the Research Group on Social Structure Change in Contemporary China, a group affiliated with the Institute of Sociology, Chinese Academy of Social Sciences. The group has focused on the process of development and change in contemporary Chinese social structure and come to the following conclusions.

Contemporary China is transitioning from a traditional agricultural and rural society to a modern industrialized and urban society; from a highly centralized planned economy to a robust socialist market economic system. The entire society is undertaking an unprecedented evolution. During the three decades of reform and opening up, China has made brilliant achievements, never seen before in history. Now, China is in a critical period of reform and opening up, with very complex, far-reaching and closely intertwined social problems, which are also unprecedented.

After deep and detailed analysis the Research Group believes that these problems cannot be resolved only by economic methods. In order to get to the roots of these social problems, China must develop new social policies, strengthen the social structure and carry out social system reform. The core purpose of the book is to recommend theories and methods on social structure to society and readers, and to investigate the development and change in China's social structure. We believe that social structure theory, a brand-new point of view to analyze the current situation, is capable of deciphering the social contradictions in China's development to some extent, as opposed to mere economic theory, which is inadequate to fully address the structural problems in China.
