The cultivation and medicinal use of orchids are Chinese traditions that date back millennia, but scientific documentation of southeast China's native orchids commenced with the establishment of European trade bases at Macau in the 16th Century and at Guangzhou in the 18th Century. João de Loureiro, a Portuguese missionary, collected *Pecteilis susannae* and *Spiranthes sinensis* during his visit to these enclaves from 1779–1782 and John Damper Parks, a collector for the Horticultural Society of London, sent back specimens of *Coelogyne fimbriata* and *Robiquetia succisa* from the region in the 1820s. The earliest survey of orchids on Hong Kong Island is attributed to Dr. Clarke Abel, naturalist aboard HMS Alceste during Lord Amherst's ill-fated diplomatic mission to the court of the Qing Dynasty in 1816, when he botanised the lower slopes of what was to become known as Mt. Victoria. The island was formally ceded to the United Kingdom following the Treaty of Nanking in 1842, and the Kowloon Peninsula and the New Territories were added to the colony in 1860 and 1898 respectively.

A century of exploration ensued: over 40 new orchids were named from plants collected within the territory, and even in the short period that has elapsed since its return to Chinese rule, Hong Kong's narrow valleys and precipitous summits have continued to yield novelties. *Collabium chinense* and *Vanilla shenzhenica* were added to the list of native orchids as recently as 1998. In total, 126 species and varieties representing all five orchid subfamilies have been recorded from Hong Kong, a staggering figure given its diminutive size. Hong Kong's landscape has changed dramatically throughout its history, and emphasis is increasingly placed on developing an understanding of the plants' ecology in order to ensure their persistence for future generations. This book provides descriptions and discusses the discovery of all the native species, and the conservation status of each is assessed. Every species is illustrated with a line drawing, and almost all are depicted in photographs taken in Hong Kong.

This book brings to fruition the work of lifelong Hong Kong resident and countrywoman Gloria Barretto (1916–2007). Gloria acquired her knowledge of botany and orchid taxonomy

under the informal tuition of Professor Shiu-ying Hu, and worked at Kadoorie Farm and Botanic Garden from 1971 until 2003. Every evening after work, she crouched over her microscope, utilising makeshift dissecting equipment, working with her collection of books, reams of data, photographs and notes, and, guided by her international network of experts, produced draft descriptions for the orchids of Hong Kong. It was always her intention that this would lead to the publication of a comprehensive account of all the native orchids, a task left to her co-authors and an aspiration now realized posthumously.

This collection of essays discusses the first commercial encounters between a China on the verge of social transformation and a fledgling United States struggling to assert itself

globally as a distinct nation after the Revolutionary War with Great Britain. In early accounts of these encounters, commercial activity enabled cross-cultural curiosity, communication and even mutual respect. But it also involved confrontation as ambitious American traders pursued lucrative opportunities, often embracing British-style imperialism in the name of "free trade."

The book begins in the 1780s with the arrival in Canton of the very first American ship The Empress of China and moves through the nineteenth century, with Caleb Cushing negotiating the Treaty of Wangxia in Macao after the First Opium War and, at the century's close, Secretary of State John Hay forging the Open Door Policy (1899). Considering Sino-American relations in their broader context, the nine essays are attuned to the activities of competing European traders, especially the British, in Canton, Macao, and the Pearl River Delta.

On 25 December 1941, the day of Hong Kong's surrender to the Japanese, Admiral Chan Chak – the Chinese government's chief agent in Hong Kong – and more than 60 Chinese, British and Danish intelligence, naval and marine personnel made a dramatic escape from the invading army. They travelled on five small motor torpedo boats – all that remained of the Royal Navy in Hong Kong – across Mirs Bay, landing at a beach near Nan'ao. Then, guided by guerrillas and villagers, they walked for four days through enemy lines to Huizhou, before flying to Chongqingor travelling by land to Burma. The breakout laid the foundations of an escape trail jointly used by the British Army Aid Group and the East River Column for the rest of the war. Chan Chak, the celebrated 'one-legged admiral', became Mayor of Canton after the war and was knighted by the British for his services to the Allied cause. His comrade in the escape, David MacDougall, became head of the civil administration of Hong Kong in 1945.

This gripping account of the escape draws on a wealth of primary sources in both English and Chinese and sheds new light on the role played by the Chinese in the defence of Hong Kong, on the diplomacy behind the escape, and on the guerillas who carried the Admiral in a sedan chair as they led his party over the rivers and mountains of enemy-occupied China.

Escape from Hong Kong will appeal not just to military and other historians and those with a special interest in Hong Kong and China but also to anyone who appreciates a good old-fashioned adventure story.

Linguistic research has dealt with culture as one of its main concerns, but popular culture has not been the main focus. Considering how readily available pop culture is across different speech communities and how routinely it is consumed by so many people on a daily basis, it is crucial for linguists to engage in systematic observation, description and interpretation of everyday cultural and linguistic practices so many participate in. English in Asian Popular Culture discusses this important, yet under-researched, sociolinguistic component of culture by looking at a region, which is still viewed as foreign or exotic 'other' in Western academic discourse. The volume features six domains of pop culture: music, TV, film, advertising, magazines, and the Internet, in a variety of speech communities in Asia including China, Hong Kong, India, Japan, Korea, Singapore, Taiwan, and the Philippines. Desiring Hong Kong, Consuming South China is a study of the complex and changing cultural patterns in Hong Kong's relationship with the neighbouring mainland. From interviews, TV dramas, media representations and other sources, Eric Ma traces the fading of Hong Kong's once-influential position as a role model for less-developed mainland cities and explores changing perceptions as China grows in confidence.

The first part (Desiring Hong Kong) examines the history of cross-border relations and movements from the 1970s, focusing on Hong Kong as an object of desire for people in South China. The second part (Consuming South China) moves to the turn of the century when, despite increased communications and a 'disappearing border', Hong Kong is no longer a powerful role model; it nevertheless continues to be an important link in the chain of global capitalism stretching across southern China.

The book will be of interest to scholars and students in cultural studies, political science, sociology and cultural geography.

The essays in this volume grew from a series of talks delivered in late 2010 as the Liang Qichao Memorial Lectures at the Academy of National Learning (Guoxue yuan) of Tsinghua University, Beijing.

Offering critical perspectives on a number of ideological issues that have figured prominently in Chinese intellectual discourse since the beginning of the so-called "reform and opening" (gaige kaifang) in the late 1970s, these essays range widely in subject matter, from Marxist historiography to sociology and anthropology in China to guoxue/national studies.

Together they are conceived as different windows into a basic problem: the deployment of culture and history in postrevolutionary Chinese thought. Dirlik touches on a number of themes, including the repudiation of the revolutionary past after 1978, which has led to a rise of cultural nationalism. He further places these developments within a global context, ultimately making a case methodologically for "worlding" China: bringing China into the world, and the world into China.
