The Pusan International Festival, South Korea Cinema and Globalization / SooJeong Ahn Aberdeen, Hong Kong: Hong Kong University Press, 2012 x. 220p. ; 23cm. ISBN-13: 9789888083596 \$ 25.00 / PB 352 gm.

This book provides a political and cultural exploration of the Pusan International Film Festival in South Korea since its inception in 1996. By paying a particular attention to the organizers' use of an Asian regionalization strategy, SooJeong Ahn reveals how the festival staked out a unique and influential position within a rapidly changing global landscape.

Very little primary empirical research has been conducted to date on non-Western film festivals, though PIFF and Tokyo and Hong Kong have swiftly grown more exciting and influential as testing grounds for global cinema innovations. The initiation, development and growth of PIFF should be understood as resulting from productive tensions in the festival's efforts to serve local, regional and national constituencies. The book also reflects the complexities of rapid transformation in the South Korean film industry as it has reached out to the global market since the late 1990s.

The essays in this volume grew from a series of talks delivered in late 2010 as the Liang Qichao Memorial Lectures at the Academy of National Learning (Guoxue yuan) of Tsinghua University, Beijing.

Offering critical perspectives on a number of ideological issues that have figured prominently in Chinese intellectual discourse since the beginning of the so-called "reform and opening" (gaige kaifang) in the late 1970s, these essays range widely in subject matter, from Marxist historiography to sociology and anthropology in China to guoxue/national studies.

Together they are conceived as different windows into a basic problem: the deployment of culture and history in postrevolutionary Chinese thought. Dirlik touches on a number of themes, including the repudiation of the revolutionary past after 1978, which has led to a rise of cultural nationalism. He further places these developments within a global context, ultimately making a case methodologically for "worlding" China: bringing China into the world, and the world into China.

This is an autobiography by Elizabeth Doery, a granddaughter of Sir Robert Ho Tung and daughter of Jean Gittins, one of whose books, Stanley: Behind Barbed Wire, was published in 1982 by the HKUP.

Elizabeth Doery was born into a minority Eurasian community in Hong Kong in 1930, but was evacuated to Australia with her brother on the eve of the Japanese invasion of Hong Kong in World War II. Her mother was interned in Stanley Camp for the duration of the occupation, then joined her children and settled in Australia. In the autobiography she comes across as a pleasant, thoughtful person. The book is well written and with some sense of drama, and will be of interest in Hong Kong among the Eurasian families and among family historians.

Ninety contributors, including prominent academics, journalists and other experts, have written entries for the collection. The contents are arranged alphabetically and include some 370 illustrations in colour and black and white. The first of its kind for Hong Kong, the dictionary will be an enduring work of reference for scholars and researchers and a source of pleasure for the general reader.

Hong Kong's history is rich in colourful characters and fascinating life stories. This illustrated dictionary collects in one volume a representative cross-section of the personalities who have made this city the cosmopolitan place it is today. The cast of characters includes men and women from diverse cultural traditions and many different walks of life. The great and the good are included: governors, admirals, film stars, taipans, writers, revolutionaries and other famous names. But there are surprises too: long-forgotten movers and shakers of their day; ordinary people who illustrate some aspect of Hong Kong history; gangsters and scoundrels — even a few eminent failures. In short, the Dictionary is a kaleidoscope through which Hong Kong's many different faces over several centuries are revealed.

In this elegant memoir, first published by the Hong Kong University Press in 1965, Grantham describes his thirty-five years in the British colonial service, which began in Hong Kong in 1922 and ended here in 1957; he also held senior positions in Bermuda, Jamaica, Nigeria and the South Pacific. Only a few of Hong Kong's former governors have published anything about their terms of office here, but Grantham's stands out as the most interesting and substantial. *Via Ports* is an important first-hand account of the workings of Britain's colonial system. It also contains vivid, often amusing anecdotes about life behind the scenes in Government House during the long twilight of the British Empire.

This collection of essays discusses the first commercial encounters between a China on the verge of social transformation and a fledgling United States struggling to assert itself globally as a distinct nation after the Revolutionary War with Great Britain. In early accounts of these encounters, commercial activity enabled cross-cultural curiosity, communication and even mutual respect. But it also involved confrontation as ambitious American traders pursued lucrative opportunities, often embracing British-style imperialism in the name of "free trade."

The book begins in the 1780s with the arrival in Canton of the very first American ship *The Empress of China* and moves through the nineteenth century, with Caleb Cushing negotiating the Treaty of Wangxia in Macao after the First Opium War and, at the century's close, Secretary of State John Hay forging the Open Door Policy (1899). Considering Sino-American relations in their broader context, the nine essays are attuned to the activities of competing European traders, especially the British , in Canton, Macao, and the Pearl River Delta.

On 25 December 1941, the day of Hong Kong's surrender to the Japanese, Admiral Chan Chak – the Chinese government's chief agent in Hong Kong – and more than 60 Chinese, British and Danish intelligence, naval and marine personnel made a dramatic escape from the invading army. They travelled on five small motor torpedo boats – all that remained of the Royal Navy in Hong Kong – across Mirs Bay, landing at a beach near Nan'ao. Then, guided by guerrillas and villagers, they walked for four days through enemy lines to Huizhou, before flying to Chongqingor travelling by land to Burma. The breakout laid the foundations of an escape trail jointly used by the British Army Aid Group and the East River Column for the rest of the war. Chan Chak, the celebrated 'one-legged admiral', became Mayor of Canton after the war and was knighted by the British for his services to the Allied cause. His comrade in the escape, David MacDougall, became head of the civil administration of Hong Kong in 1945.

This gripping account of the escape draws on a wealth of primary sources in both English and Chinese and sheds new light on the role played by the Chinese in the defence of Hong Kong, on the diplomacy behind the escape, and on the guerillas who carried the Admiral in a sedan chair as they led his party over the rivers and mountains of enemy-occupied China. http://www.marymartin.com/web?pid=136489

Desiring Hong Kong, Consuming South China is a study of the complex and changing cultural patterns in Hong Kong's relationship with the neighbouring mainland. From interviews, TV dramas, media representations and other sources, Eric Ma traces the fading of Hong Kong's once-influential position as a role model for less-developed mainland cities and explores changing perceptions as China grows in confidence.

The first part (Desiring Hong Kong) examines the history of cross-border relations and movements from the 1970s, focusing on Hong Kong as an object of desire for people in South China. The second part (Consuming South China) moves to the turn of the century when, despite increased communications and a 'disappearing border', Hong Kong is no longer a powerful role model; it nevertheless continues to be an important link in the chain of global capitalism stretching across southern China.

The book depicts gay paradises in Southeast Asia and the men who created them. It studies the obstacles gay men have faced in securing a voice as citizens, and how they used images of paradise in Bali, Bangkok, and Singapore to create a sense of refuge, construct homes for themselves, and dissent from typical notions of manhood and masculinity. For gender studies and Southeast Asian studies, it provides a "queer reading" of Walter Spies, a gay German painter who in the 1930s helped turn Bali into an island imagined as an ideal male aesthetic state. Secondly, the book provides a historical account of the absorption of Western notions of romantic heterosexual monogamy in Thailand during the reign of King Rama VI and the resistance to those notions expressed through an architectural paradise called Babylon founded by a Thai known as Khun Toc. Finally, it describes the "cyberparadise" of Fridae.com created by a young Singaporean named Stuart Koe. Collectively, the study examines the pursuit of sexual justice, the ideologies of manhood they challenged, and the geographic and online spaces they created.
