The Second Constitution intellectuals aimed to change not only the state but also the society. The Committee of Union and Progress saw women as the key to this change and decided to increase the public appearance of women as a sign of modernity, and to make public use of the female energy as an economic necessity. With the Declaration of Freedom, the image of “the ideal woman” as “a good Muslim, a good wife and a good mother” was imbued with “the creative woman” image who would raise the kids to “civilize” them with revolutionary principles such as “freedom, equality, justice, and fraternity.” Thessaloniki, the political and cultural center of the Young Turks, was also the experimental region for women’s organizations through charity work. The most political of the three women’s magazines during the Second Constitution period was Kadin which started to be published in Thessaloniki. Kadin tried to redefine women’s public and private roles and duties, to cover the rhetoric of educating women and important political pointers. The objective of this book is to demonstrate how the “Young Turk feminism” was shaped by the solidarist politics of the Committee of Union and Progress under the vestige of “conscientiousness” and “progress”. This book aims to investigate constructions, and discourses about the “Second Constitution Woman” and how women got involved in these polities. It also claims that the establishment of the identity of the “new woman” that started with the Tanzimat period reform movements and continued until the Republican period goes back to the Second Constitution period.

The journalist Defne Kaman is being prosecuted for her article “Why Not Nuclear Energy?” In Kayseri, where the trial is being held, Defne Kaman is joined by Turkey’s renowned environmental lawyers, journalists, animal and environmental rights activists and NGO representatives. The day Defne Kaman arrives in Kayseri a bust mysteriously disappears from the city center. It is the bust of Gevher Nesibe, a female Seljuk sultan who, in 13th Century Kayseri, built one of the world’s first medical schools, as well as a hospital that treated patients with music. In addition to the determination of the Turkish government, the United States' entrance into the war and their support of the Turkish government, and international law toward neutral states empowered and enabled the Turkish non-belligerent policy to endure throughout the war. This book inspects the reflections of the ideological aspects of a nation-state's over childhood issue of the political powers of both the early Republican era and the AKP government concerning two different children's magazines called *Gürbüz Türk Çocuğu* and *Sevgi Bir Kuş*. Hence, it is significant to examine the literary products in the children's magazine published by the "Children's Protection Agency", one of the official instruments of the State, to see how the discourse of the power changed over time in the context of children's policies and a nation-state. This book deals with following questions: What characteristics did children's magazines possess concerning the language and the wording? Was the language used in the magazines appropriate for the child readers and leveled with the daily language? Was the wording used in the magazines didactical and peremptory? Who were the readers or the targeted audience of these magazines? Did the magazines only address the children? What were the ethical elements that were idealized? What kind of bond was established between the analyzed era and the ethical understanding that was valorized? How did this situation affect the idealized ethical virtues? Did the ethical understanding have a discourse shaped in the axis of the necessities of the daily practices? Did ethical values have different determiners or definitions for boys and girls? How did they cover these cases in the narratives?

At the end of the 19th century, a distinguishing characteristic of the Russian Empire was its cultural, religious and ethnic heterogeneity, in relation to which, a number of significant questions could be raised: to what extent are modern theories of nationalism relevant in explaining the centrifugal tendencies of borderland peoples in Russia at the turn of the 19th century? How could the nation become the main concern of the masses, transcending both religious and economic values? How specific was this process to Southern Caucasus? This book is an attempt to answer these questions with reference to a historical/geographical evaluation of Azerbaijan, the uniqueness and particularities of its political processes. In this context, class conflict, Western and Russian influences, inter-ethnic tensions, the Jadid reformism and the relative autonomy of political elites will be discussed, and it will be argued that if Azerbaijan could form the first secular state of the Muslim world, it was due to its well-educated nationalist intelligentsia, backed by an enlightened bourgeoisie.

The main objective of this thesis is to explore the Turkish state's attempt to regulate Islam through an analysis of the regulation of Friday sermons in Turkey. Drawing on the records of disciplinary measures implemented by the Presidency of Religious Affairs (PRA) and in-depth interviews conducted with imams in Turkey, the thesis argues that the Republic developed strategies to realize a state centralization of religion. This is corroborated by the high compliance rate of imams with the content of the sermons prepared by the PRA in the absence of serious inspection mechanisms until relatively recently. The compliance of imams to the sermons delivered by the state implies that a distinct (nation-) statist disposition has been approved by the imams themselves as well and hence that the republic has managed to create the "republican" imams.
