Synthesizing empirical findings and secondary information the study attempts a causal explanation of connections and interrelations of reasons behind landlessness. The actual and also perceived reasons have been analysed through such traits and household conditions like needs, well being, capability, constraints, motivations, options and opportunities. Rural (landless) households experience land loss and also at times, land gain. These changes in land ownership are in response to household needs and the capability to cope with needs that change over time. The importance of time, location and individual disposition in the study of household landlessness bas been highlighted here. People-young of age, illiterate and unskilled, occupied mostly as agricultural wage labour, were presently heading the fragile floodplain household under study. One third of these households have already experienced lifetime landlessness and a vast majority remain vulnerable-little slips are liable to make them trip and tumble. With its nuanced insights into theory and methodology, readability and comprehensive coverage, this book will attract wide readership among students and scholars of rural development, social ecology, anthropology, livelihood and environmental studies.]

[This study looks into the vulnerability and coping mechanism of those affected by riverbank erosion in north-west Bangladesh. It traces their struggle through various phases: pre-displacement, disaster management, rehabilitation and long-term livelihood management. Instead of attempting to alter the course of nature, the study underscores the need for institutional mechanisms to help the affected people in coping with adverse consequences. Riverbank erosion has a devastating impact on the lives and livelihoods of the affected people. They lose out in many ways,

materially and in social terms. Displacement impinges on the occupational patterns of the households and brings about major changes in the family structure as often members of households are forced to migrate to earn a living. Displacement exacerbates the process of women's participation in the public sphere. As traditional gender division of labour within the household does not experience commensurate change, the burden of displacement falls disproportionately on women. The institutional responses of the government and NGOs in addressing the plight of the displaced people gave also been analysed. The study recommends a concerted effort of the government, NGOs and other civil society institutions to address the plight of the affected people. It argues that government and non-government sectors need to develop creative programmes to cater to the needs of this marginalised group. It also recommends increased emphasis on promoting rights based approach so that the affected people can stake a claim on the state.]

Although writing history was their self-inflicted parttime occupation, yet their writings were amazingly voluminous and distinctive. M. D. Hussain has charted out how history writing progressed in their hands. [The Kantajee Temple of Dinaipur is one of the most magnificent religious edifices to have survived from to have survived from the late medieval period. Its construction was begun by Raja Prannath during his reign (1682-1722), and completed by his successor and adopted son Ramnath in 1752.

The temple is dedicated to Lard Krishna and his wife Rukmini. It is an Indo-Islamic type of pinnacled, or nava ratna (nine-towered), temple though today its towers are ruined. The temple's ground plan, execution and ornamentations are the very essence of Bengal's late medieval temple style. It is decorated from top to bottom with exquisitely carved terracotta panels, arranged both horizontally and vertically. The horizontal friezes depict the life of the medieval aristocracy as well as the life stories of two mythical heroes, Rama and Krishna. The vertical panels display Rishis (sages) and the ten incarnations of Vishnu.

The Kantajee Temple is still a living one, where people from the surrounding region pray and perform ritual warship every day. This unique temple is a national heritage of Bangladesh.]
