He has become a household name among the academia and learned readerships by virtue of 14-volume magnum opus Banglapedia [National Encyclopedia of Bangladesh]. After going into voluntary retirement from Dhaka University in 2000, he devoted himself to the task of turning the Asiatic Society of Bangladesh in to a vibrant and premier non-government learned body of the country. He is now widely recognized as the builder of the modern Asiatic Society.

The book also notes the recognition by the Plan of the possibility of alternative philosophies regarding water development. At the same time, the review notes the Plan's lack of appropriate formulation of its tasks; biased appraisal of Bangladesh's past water development experience; ineffective treatment of the transboundary issues; partial attention to the Netherlands' delta management experience; and the reluctance to follow consistently the water development philosophy that is more appropriate for Bangladesh.

As a result of these weaknesses, the Plan could not give birth to its own plan of action and instead relied on pre-existing project proposals of the implementing agencies to put together its project portfolio. Instead of ushering in a new stage, the Plan thus left the water

The political and economic history of East Pakistan during Pakistan period was the history of deprivation of the East Pakistanis by the West Pakistanis. The deprivation was in the form of national power imbalance, which led to the denial of Bengali participation in the central decision-making process and of the economic disparity in the disfavor of East Pakistan. The regional power imbalance was created by the civil-military bureaucracy dominated by the West Pakistanis, particularly the Punjabis, who had a long tradition of

bureaucratic participation, which automatically limited the intermediate Bengali participation in the government. The economic disparity was twisted in the form of publicprivate investment and the use of foreign aid and surplus trade balance of East Pakistan in West Pakistan and of inter-wing trade. These factors led to the growth of politics of regionalism in East Pakistan, and the elites there were compelled to launch strong mass movements for regional autonomy. Consequently, East Pakistan declared independence on 26 March 1971 and got liberated from Pakistan's occupation on 16 December of 1971 after nine months of the War of Liberation, and thus emerged independent Bangladesh. http://www.marymartin.com/web?pid=869439

Historian Ali traces British fears of revolutionaries and their plans; despite public dismissals, in private the Raj was always concerned, casting worldwide surveillance nets and arraying sinister agents and collaborators to monitor revolutionaries–and thwarting their activities where possible.

The only leader of Congress to emerge in the inter-war years who supported the outright and complete overthrow of the Raj by armed insurrection; Bose became an enemy of both the Raj and the Gandhian Congress; characterized as

its one "implacable foe" by the Raj, while Gandhi frankly admitted to an Imperial Viceroy, speaking of Bose, that "he is my opponent."

Insurrection coupled with a distinctive vision for a national revolution in the subcontinent meant that Bose also faced two implacable foes; imperial occupier and domestic enemies.

Ali argues that it was Bose and the revolution he represented that posed the real threat to the Raj and its collaborators in the subcontinent.

Implacable Foes also speaks for the enduring applicability of Bose's life and message, a generous secularism and forward-thinking progressivism, in the present-day; in a subcontinent still grappling with the poisonous legacies of British imperialism and the spectre of two nuclear-armed states facing off against each other; for the future of amity and equitable relations in South Asia.

Women in Kabinnama deals with a brief history of the conjugal relations in Muslim families in the nineteenth century Bengal. The author, Dr. Bilkis Rahman, has attempted to reconstitute the nature of the relationships between husband and wife based on a meticulous and thorough study of the marriage deeds (kabinnama). She examined the terms and conditions in 122 marriage deeds of Muslim families belonging to the nineteenth and the first half of the twentieth century.

While the religion of Islam permits a man to marry up to four women, the marriage deeds examined by the author show that men were discouraged to marry more than one woman and there were several clauses in a marriage deed safeguarding the interest of women, even ensuring the right of divorce on the part of women. Some marriage deeds testify that the position and status of women in Muslim families was extremely high. The main objective of the book is to highlight the fact that the provisions laid in the Muslim Family Law Ordinance, 1961 in respect of marriage, divorce, subsistence etc. are not unprecedented. Rather, an analysis on the terms and conditions asserted in 122 marriage deeds will show that some arrangements were already made in safeguarding the interest of the women.

As social conditions changed, the author maintains that Muslim women enjoyed less and less freedom and rights for various reasons. The investigation carried out by the author indicates that due to the recognition by the society that women represented a weaker sex, the Muslim Family Law attempted to stop deteriorating conditions of women. It would be interesting to note that today's Muslim women do not enjoy the same degree of protection that the women of the nineteenth century did, she concludes.

Lalu delivers water to all the houses and shops which require his services, including the house of the Punjabi Jamil Bhatti. When the family is in danger, Lalu risks his life to protect Jamil Bhatti's son. However, after the insurgency fails, Lalu reacts violently to something derogatory that the young man says, with fatal results.

While telling the story of a freedom struggle which was brutally suppressed, the novel seems to foreshadow the continuing conflict in the region. Though North West Frontier Province has been renamed Khyber Pakhtunkhwa, the suppression of Balochistan continues.

Though newly elected President loe Biden rushed to restore American leadership abroad, the international community had its doubt about Washington's credibility. Biden's abrupt troops withdrawal from Afghanistan without prior consultation with European partners and neighboring countries in Asia could not win sceptics at home and abroad. Russia's protracted war in Ukraine and annexation of four eastern regions following a farcical referendum on 30 September 2022 do not bode well. Moscow's threat of resorting to nuclear weapon to score victory over Kyiv endangered peace in Europe. Hope and Despair is a collection of essays I wrote on the above issues in the past three years. These were duly published in the Financial Express, Dhaka; some with different headlines.

This collection of brief essays by Siddhartha Shankar Joarder, first published in newspapers over the last three years, provides an example worth emulating, of a scholar stepping out of the ivory tower and into the world of everyday life. A philosopher by training and profession, Dr. Joarder offers critical discussion of an extraordinary wide variety of issues that is characterized by the virtues of philosophy: intellectual humility, precision, and cogency. Topics covered range from the lives and legacies of Bertrand Russell and Rabindranath Tagore, the philosophy of anti-natalism, the state of education in Bangladesh, and the role of science and philosophy in maintaining peace and facilitating development to the history of democracy in Bangladesh, with all its challenges and achievements, the democratic ideals of equality and liberty, the rise of terrorism, the seductive lure of power, and sexual violence against women. As is clear from this list, Dr. Joarder does not shy away from issues that are difficult and often controversial, which is why many readers will not find themselves able to agree with all that he writes. I myself disagree, for example, with his views on the limits of free speech, as laid out in his discussion of the 2018 arrest of Shahidul Alam. But rather than being a shortcoming of the book, this shows its importance. Thoughtful and civil conversations about issues over which we disagree are the ones that really matter.
