Journeying eastward from the massif of Kanchenjunga, which dominates the Indo-Nepal border, the authors take us through Sikkim, Assam, Meghalaya and Arunachal Pradesh before moving southwards along the Naga Patkai Range to the hill states of Nagaland, Manipur and Mizoram, coming to a halt in Tripura. The Northeast is home to many indigenous tribes—diverse peoples with distinct cultures—whose long and complex histories of migration, settlement, and eventual accession to independent India are traced here. Detailed glimpses into the lives and beliefs of these communities also lay bare the grave ecological threats facing this fragile region, with the rapid depletion of natural resources. Providing ballast to this comprehensive inquiry are stunning visuals of the Himalayan Range and the many diverse ecospheres of the Northeast, including the Khangchendzonga, Manas and Kaziranga National Parks, all UNESCO World Heritage Sites.

This book interleaves the history of post-Independence archaeology in India with the life and times of Madhukar Narhar Deshpande (1920-2008), a leading Indian archaeologist who went on to become the director-general of the Archaeological Survey of India. Spanning nearly a century, this is a tale told through a main character—Deshpande himself—some of whose writings have been included in the volume. We explore the circumstances which brought men like Deshpande to this career path; what it was like to grow up in a family devoted to India's freedom; the watershed moment that created a large cohort that was trained by Mortimer Wheeler, the doyen of British archaeology; the unknown conservation stories around the Gol Gumbad in Bijapur and the Qutb Minar in Delhi; the forgotten story of how the fabric of a historic Hindu shrine, the Badrinath temple, was saved; the chemistry shared by the prime minister, Jawaharlal Nehru, and the archaeologist, Deshpande, at the Ajanta and Ellora cave shrines, and; the political and administrative challenges faced by director generals of archaeology. Dr. Balkrishna Doshi is foremost among the modern Indian architects. An urban planner and educator for the past 70 years, Dr. Doshi is a Fellow of the Royal Institute of British Architects and a Fellow of the Indian Institute of Architects. In 2018, Doshi was selected as the Pritzker Architecture Prize Laureate, internationally known as architecture's highest honour. Apart from his international fame as an architect, Doshi is equally known as an educator and institution builder. This autobiography captures Doshi's career from his childhood to his studies in Bombay and London, his work at Atelier Le Corbusier in Paris and collaboration with Louis I. Kahn for IIM Ahmedabad. It recounts his meetings with the most remarkable persons in his own and allied fields, and his equally remarkable patrons. Doshi's life from the time he was born into a modest family in the by-lanes of Pune, and his struggles and tenacity to excel in his chosen fields—is a fascinating and inspiring story. Put together, for the first time, from the lifelong diaries and notes maintained by him, Paths Uncharted is a personal recounting of this remarkable journey unfolding over more than 80 years and across all the continents.

Aditya Prakash (1924–2008) belonged to the first generation of Indian modernists that came into its own in the Nehruvian era. Built around a multidisciplinary oeuvre that was unique amongst his peers, Prakash's life was dedicated to finding the "one continuous line" which linked art— as the search for the beautiful, architecture—as the enabler of life, and

planning—as the ethic of protecting the interests of poor. Interspersed with a series of visual essays, this book is conceived as an introduction to Prakash's vast body of work. Besides practising architecture, he was an academic, a prolific painter, sculptor, furniture designer, stage set-designer, poet and public speaker. This volume documents Prakash's education as an architect in Delhi and London, his early modernist works, his deep artistic impulses, his love of theatre, and his e,,orts to rally a culture of academic inquiry. The narrative describes his successes and failures, his arguments for and against modernism, postmodernism and globalization, and his passion for sustainable urbanism, the animal and the acoustic. The book concludes with an interpretive essay on Prakash's life and legacy, along with lavish illustrations of a portfolio of select works.

Manoj Dutta was born in Kolkata (then Calcutta) in 1956. Despite having no formal art education, he soon came to the fore as a talented artist in the late seventies. His art stands out for being rooted in native styles, and indeed, his works look inalienably Indian more o"en than not. However, he isn't simply recycling ideas from the traditional or the Bengal schools of art. While relying on traditional ideas of art for visual meaning-formation particularly folk art—Dutta integrates these modes with a distinct modern sensibility, especially in his treatment of contemporary events. This volume by the renowned art critic Manasij Majumdar takes as its subject Manoj Dutta, by the author's own admission one of his favourite artists. Majumdar has admired for many years Dutta's paintings and drawings, which tend to look spontaneously home-grown, yet modernist at the same time. Today, his works have travelled far and wide, admired and collected by art-lovers worldwide, who appreciate in his art a lucid, unalloyed expression of something very much native to the Indian soil. Based on the collections accessible in Kolkata and Delhi, as well as Dutta's own

Jungles where man met the spirit of the wild, yogis who harnessed the deepest powers of the mind, Destitutes who had no more want than the veracity of their tradition, valorous aryans who were also "warm and brown", and profligate maharajas whose extravagance could outdazzle any other court of the world—the contrasts of temperament, habitat and colour, depth of spirituality and sumptuous sexuality became the standard fare of the clichés that typified India in the intellectual and artistic circles of the West at the height of colonialism. Less well known is that this was accompanied by a strong move toward a particular vocabulary of abstraction in visual form, spiritual discourse, music and theatre. The

exchanges with ideas Indian, and with Indians themselves, had a decisive impact that contributed to the eruption and shape of Modernism in the West.

This volume, richly illustrated and including several unpublished artworks, reveals the great artists of Europe in a new light. It also brings into focus lesser-known artists of no small Importance, and expands the frontiers of the known influences of India beyond the European mainstream to Sweden, Russia and North America. It explains how Indian ideas impacted Natalia Goncharova and Hilma af Klint alongside Wassily Kandinsky and Piet Mondrianin the world of painting. Stanislavsky and Tairov, giants of the stage, both read yoga in Russia. Set designs and dance costumes for the Ballets Russes' Anna Pavlova, as well as German and French theatre directors are examined. And finally, the book takes in its purview a number of intellectuals: Carl G. Jung, Ananda K. Coomaraswamy and Rabindranath Tagore along with leading Theosophists, making it a book of rare historiographic insight.

Haloi's observation of the submerged and floating aquatic plants, their gentle movements and lifecycle has been an enchanting experience, which resurrects continually through glowing layers of colours and floating shapes and lines. He also induces an incessant drama that seems to be an organic part of nature and independent of any human intervention. But when this hydrosphere dries up or disappears, Haloi reacts profoundly with an inevitable pain. This volume attempts to illuminate these recent works and their expression of a pain that is personal as much as it is historical.

In this volume, Peter Bjorn Franceschi presents a photographic exploration of the mother goddess in the making, a visual diary of the clay idols of the goddess Durga, from conception to finished form. The book takes us through the winding lanes of Kumartuli, home to the master artists who craft the clay idols of the Devi for the Durga Pujo. Accompanying these photographs are verses from Sankaracharya's poetic work, Saundaryalahari (Waves of Beauty), translated by the scholar Minati Kar. The work is a paean to the goddess Durga, entwining Advaita Vedanta and Tantra philosophy to paint a splendid picture of Devi, starting from the crown of her head and ending at her feet. These poetic descriptions serve as a deeper layer to the visuals, and as an alternate way of interpreting the process of image making. Delving deep into the philosophical and artistic aspects of the divinity of goddess Durga, this volume is a visual celebration of her many forms, and also of the artisans who have occupied a centuries-old caesura between devotion and art.

Narendra Modi has been a hundred years in the making. Vinay Sitapati's Jugalbandi provides this backstory to his current dominance in Indian politics. It begins with the creation of Hindu nationalism as a response to British-induced elections in the 1920s, moves on to the formation of the Bharatiya Janata Party (BJP) in 1980, and ends with its first national government, from 1998 to 2004. And it follows this journey through the entangled lives of its founding Jugalbandi: Atal Bihari Vajpayee and Lal Krishna Advani.

Over their six-decade-long relationship, Vajpayee and Advani worked as a team despite differences in personality and beliefs. What kept them together was fraternal love and professional synergy, of course, but also, above all, an ideology that stressed on unity. Their partnership explains what the BJP before Modi was, and why it won.

In supporting roles are a cast of characters-from the warden's wife who made room for Vajpayee in her family to the billionaire grandson of Pakistan's founder who happened to be a major early funder of the BJP. Based on private papers, party documents, newspapers and over two hundred interviews, this is a must-read for those interested in the ideology that now rules India.

From Truman's remark to now, it has been a long journey. India and the US, which share common values and should have been friends, found themselves caught in a dysfunctional cycle of resentment and mistrust for the first few decades following Indian independence. But despite the fact that Rama is regarded as the epitome of dharma in his thoughts and deeds, the Ramayana does not provide us with one single

template for right action. Nor does it tell us that dharma is beyond the reach of human understanding and human action. On the contrary, it holds out the promise that everyone can and should search for a dharma they can believe in, a dharma that is vulnerable but all the more precious because it has been sought and found rather than given and received.

In her thought-provoking new book, renowned Ramayana scholar Arshia Sattar writes with compassion, tenderness and insight about dharma as a multiplicity of appropriate choices, showing us that when we choose one way of being and doing over another, we will be as often wrong as we are right.

The twelve articles assembled in this first volume of the author's Collected Papers in Jaina Studies, written in English, were published as journal articles and book chapters between 1996 and 2016. They are reproduced here in almost identical form, though an attempt was made to eliminate typographical errors and minor mistakes. Three articles, chapters 2, 6, and 11, which, on request, were first published without the use of diacritical marks, have been changed back to their original format. In a few cases, the biographical data of recently deceased individuals were updated.

The articles address aspects of the history, doctrine, organisation, and ways of life in Jaina mendicant orders, sects and schools, following an overview of the contemporary monastic traditions. The majority are outcomes of a long-term research project, covering a period of over 30 years, on the aniconic or amūrtipūjaka Śvetāmbara Jaina traditions, which had been neglected by modern scholarship and, with the notable exception of the Terāpanth and the Śramaṇa Saṃgha, are still almost unknown even in India itself. Two articles pertain to the Akrama Vijñāna Mārga, a new syncretistic religious movement, combining Sāṃkhya ontology with Jaina soteriology.
