This volume is a collection of eighteen ethnographic essays on Anthropological Explorations in East and South-East Asia, reprinted from Journal of the Anthropological Society of Bombay, published during 1886– 1936. Divided into five parts, it includes works on history, religion, tea cult, the Torii of Japan and the Torans of India; on the veneration of the dead in China; on Tibet and its customs and practices, the Lamas and folklore in eastern Himalayas; on the monastic institution of Burma and its Phongys; Malay folklore, folk medicine, etiological folktales; and Burmese and Indian folk beliefs. This volume provides evidence that the history of anthropological writings in India is much older than is believed to be. This volume bears witness to indigenous scholarship of civilized societies such as China, Burma, Tibet and Japan. This volume will be beneficial for the study of the impact of Buddhism, Taoism, Confucianism and Hinduism in East and South-East Asia.

Ethnicity, Identity and Culture: Scheduled Tribes of Andhra Pradesh and Telangana / Malli Gandhi Jaipur, Rawat Publications, 2021 294p.; 25cm. 9788131611531 \$ 37.50 / HB 750gm.

Indian democracy has been rooted on the twin pillars of distributive justice and inclusive growth. Recognizing this, the State has been empowered to take affirmative action in favour of historically disadvantaged social groups such as the Scheduled Tribes (STs) through reservation. So far, 705 Scheduled Tribes have been notified under Article 342 of the Constitution, spread over different States and Union Territories. Andhra Pradesh and Telangana states are the home to 35 tribal communities. They comprise seven per cent of states' population. These tribal groups are the largest tribal concentration in South India. The scheduled area of Andhra Pradesh and Telangana is covered by Tribal Sub-Plan. These indigenous tribal communities are mostly concentrated in hilly tracts. Development policies of the successive governments were characterised by several controversial initiatives and resulted in the eviction of tribal population from forests. This has diluted the spirit of Fifth Schedule. There are no special courts and exclusive laws to safeguard their basic rights and protect them from atrocities. A comprehensive policy is still long overdue. If protective laws are not strengthened effectively, there will not be any improvement in the lives of adivasis (tribals). The present work is important in the sense that it takes a look at tribal development in Andhra Pradesh and Telangana states. Extensive filed work has been conducted in these two regions and advices of social scientists, tribal welfare administrators and academicians have been considered in the narrative. It is expected that the present work will be of great help in conducting research on similar problems in India in general and Telangana and Andhra Pradesh in particular. http://www.marymartin.com/web?pid=774337

On close examination, we can easily state that it has been the state, market and even civil society that are the reasons for the disadvantage of the tribes. Most of the chapters in this volume are microlevel studies with reference to a particular region or a tribe. However, the chapters in part one of this volume deal with policy concerns at national level. The tribal issues discussed in this volume are culture, development, globalisation, health, identity politics, language, policy, poverty, violence and women, with reference to a particular region or with a specific tribe. While building various arguments on the issues concerned, one can connect the role of state-market-media in the forefront, either directly or indirectly. Therefore, the interconnection and role of these three would always be debated while discussing tribal issues in the Indian context. Overall the book tries to present a comprehensive analysis on the reasons for tribal exclusion in India.

The essays in this volume focus on the surviving remains in India of promoter public buildings like series, bridges and water-works of different types as well as masonry structures meant to extract indigo or sugar from plants. Much of this evidence is significant for the study of economic history as well as war technology of the post-Turkish conquest phase. The attempt here is to present this evidence in the perspective of the evolving production technology which appears to have received an impetus with the establishment of Turkish rule. The archaeological data cited in this collection of essays indicate the presence of extensive promoter remains along the Mughal highways, many of which have not been recorded so far. These make for very promising objects of study for archaeologists as well as students of economic history interested in determining the factors responsible for India's sluggish transition to modernity. It therefore becomes interesting subject for social anthropologists to see the unfolding of the nature of change at different levels and times in the history of tribal societies.

Weaving Hierarchies: Handloom Weavers in Early Twentieth Century United Provinces combines primarily historical data with extensive field research to give us new insights into the structures of artisan trades and the lives of weaving communities specifically located in the weaving hubs of Azamgarh, Gorakhpur and Fakirabad divisions of eastern Uttar Pradesh during the first half of the twentieth century. Thus, it fills an important gap in the existing labour historiography, which has tended to focus more on 'modern' sites of labour such as factories, mines and plantations. The book explores the modernity/tradition dichotomy as it has been applied and amplified in our understanding of development, demonstrating that some of the categorizations fundamental to these understandings are in fact profoundly misplaced. Indeed, the argument regarding processes of 'localization' made here is particularly promising in the sense that it does not posit localization in opposition to but in tandem with global processes. In Pursuit of Justice : An Autobiography / Justice Rajindar Sachar New Delhi: Rupa Publication India Pvt. Ltd., 2020 254p.; 24cm. 9789390356676 \$ 15.00 / HB 580g

The story of a great jurist who was an even greater human being. Justice Rajindar Sachar was a socialist, an egalitarian, a defender of civil liberties, a deeply engaged citizen of India, and, above all, a humanist. A man who believed in standing for the last man in the line, he was 'armed' with a moral compass that never wavered. Born into an influential family from Lahore in 1923, he witnessed the pain of Partition. Yet, amazingly, he never bore any animosity towards Pakistan or its people. Son of Chimes Sachar, a prominent Congressman and Gandhian in pre-Partition Punjab and Chief Minister of Punjab post-1947, Rajindar did not disclose his famous surname during his early life to ensure people would not give him special treatment. He joined the Delhi High Court in 1970 but was transferred out of Delhi for voicing his opposition to the Emergency. During those dark days he shared a close bond with Justice H.R. Khanna, the lone voice of dissent in a Supreme Court that chose to side with Indira Gandhi. Brought back to Delhi after the Emergency, he rose to become the Chief Justice of the Delhi High Court. Post-retirement, Sachar helmed the People's Union for Civil Liberties for many years. However, what Justice Rajindar Sachar is mostremembered for is the Sachar Committee Report (2006) which documented the social and economic condition of Muslims in India. The Report drew both praise and criticism, with some radical elements even threatening to send him back to Pakistan. However, his fight to preserve the secular fabric of India continued till the day he died. His autobiography comes at a critical time when India's democracy is under siege from within.

Raja Rammohun Roy (1774-1833) was a great champion of liberty and civil rights in colonial India. He was also a true cosmopolitan who envisioned a world without borders. A tireless crusader for religious and social reform, Rammohun attempted a progressive reinterpretation of Hinduism and tried to improve the lot of socially marginalized groups such as women. Yet, in spite of his lofty public presence, Rammohun was a hugely controversial figure. He shocked the Hindu orthodox by his support to the abolition of sati, offended evangelists by separating the moral message of Christ from the purely theological, and was often dragged into legal disputes over family property. By the time of his death in Bristol, he was as much resented as respected, both at home and abroad. Using relatively unexplored sources, this elegant and accessible new biography by Amiya P. Sen paints a fascinating portrait of one of the legendary makers of modern India.

Development of the Tejas fighter aircraft was independent India's most ambitious aeronautical project. A group of visionary academics, engineers and scientists was convinced the country had the talent to undertake this journey on a road filled with many unknowns. The Government of India which always wanted the nation to achieve self-reliance in high technology fields like aeronautics and space backed the idea. The Aeronautical Development Agency (ADA) was established in 1984 to manage the project. Hindustan Aeronautics Limited (HAL) was the principal partner in the project because it was the only organization in the country which had a design bureau and the infrastructure to manufacture prototypes and serially produce the aircraft. ADA, which was placed under the Defence Research and Development Organisation (DRDO), was strongly supported by many DRDO laboratories in particular the Aeronautical Development Establishment (ADE) and the National Aerospace Laboratory (NAL) under the Council for Industrial and Scientific Research. It was undoubtedly a mammoth multi-disciplinary effort requiring good project management skills. The grant of Final Operational Clearance (FOC) for the aircraft, development of the trainer version, arrested landing of the Naval version on the carrier and the equipping of two front line fighter squadrons with the Tejas is testimony to the dedication and technical virtuosity of Team LCA, an omnibus term for the many hundreds of men and women who contributed to the success of the project. This book is about the inspiring journey of the Tejas from concept to entry into squadron service. A must read book for all Indians.

There were corruption scandals causing widespread street protests, plenty of late-night decision-making which one knew would rock the stock market the next day and getting to know politicians who were outstanding as statesmen in the midst of all this, as well as many who were not. The World Bank years ranged from interacting with officials in tiny, remote countries like Samoa, to gigantic nations with considerable heft, such as China. It entailed sitting down with leading researchers to compute and announce global numbers on extreme poverty and rankings on how easy it is to do business in different countries (fully aware that there would be calls from irate finance ministers as soon as these were published), and assisting quarreling nations to communicate amicably and coordinate on policy. Base narrates these momentous periods in his diplomatic career with a rare light heartedness which not only informs by giving the readers a ringside view of Indian bureaucracy, but also makes this book the most compelling and enjoyable book on policymaking to come out of India in years.

With the Covid-19 induced lockdown adding to these obstructions, it is clear that direct rule by the central government is no panacea for development in Jammu and Kashmir.
