The book commences with a short wrap-up of the history of Cambodia with the arrival of Sage Kaundinya and comes down to the coronation ceremonies of Cambodian monarchs to whom the brahmin Grand Master hands the statues of Lords Siva and Visnu as the keeper of Divine Values (dharmaraja), and the Sacred Sword with the mantra Take, for Thou art the Lightning of Indra. The Grand Master is called Rama-rajya-adhipati. Prof. RaghuVira wanted to publish all the 442 Sanskrit inscriptions of Cambodia

in Devanagari and their facsimiles. Prof. Coeaes sent their list which has been reproduced here. It shows how Sanskrit was the language of the state till the 12th century. After long-drawn negotiations the Government of Cambodia sent monk Ven. Candravarna in 1961. He obtained the Ramakirti from his uncle (parts 1-6, 8-10, 75). He used to transcribe the Cambodian text into Devanagari and give a resume which wrote down in English. Both have been reproduced here.

Naṛṛiṇai Nāṇūru (Naṛṛiṇai Four Hundred), called Naṛṛiṇai in brief, is a collection of 400 Akam verses (excluding the invocatory verse) and is by tradition counted first among the eight anthologies of the Caṅkam period. The verses of this anthology vary in length from 9 lines to 12 lines, except verses 110 and 379 which have 13 lines each. Verse 385 has come down to us only partially (7 lines); verse 234, believed to have been lost, is now traced to the illustrative verse of Iṛaiyaṇār Akapporuļ verse 28, found in its commentary. On the basis of the remaining 396 verses, it can be said that Naṛṛiṇai represents a middle position, in that Kuruntokai verses vary in length from 4 to 8 lines, while Akanāṇūru verses vary from 13 to 31 lines.

The patterns of the line length of these three Akam anthologies may point not only to the structural unity of each of these three anthologies but also to the fact that anthologization of the Akam poems has been done on certain criteria of form and structure.

Kuruntokai is an akam anthology compiled on the basis of the metre and length of the poems. There are three metres used in the 'Eight Anthologies' and the poems using āciriyappā metre are divided into three anthologies on the basis of the number of lines in the poems. Kuruntokai is an anthology of 401 poems that are between four and eight lines in length. However, there is one poem of nine lines. There are 205 poets represented in the anthology. Its kaṭavuḷ vālttu, the invocatory verse, is not numbered. This may be due to the inclusion of Kuruntokai 307 which transgresses the length of verses in this anthology as it is the only poem containing nine lines. Kuruntokai is accompanied by a note giving a tradition as to its compiler. The note says that the anthology was made by Pūrikkō about whom nothing is known. There is a tradition embodied in two verses of unknown date and authorship that Naccinārkkiniyar wrote a commentary on 20 poems of Kuruntokai.

It maintains that the verbal constructions of ceyum, ceyuntu, cey(u)pu (>ceyyuū), and cey(u)ku types of early Tamil are identifiable as non-past impersonal finite constructions originally. It maintains that the early Dravidian finite system was impersonal in character without reference to person/gender appendage. The agreement markers are treated as the complementary variants of the personal pronouns. Although, the Dravidian syntax is of SOV type synchronically, it should have originated in OVS system with gender/person markers representing original pronominal subject NPs. The syntax of negation and certain relative clause constructions that have gone out of use are brought to notice. Such complementizers as an in, am, um and their variants attested in Tamil are treated as the alternants of Be verb which in course of time is considered to have lost their lexical meaning.
