How 'new' was the new middle class anyway? Lifestyle and material culture practices in the suburb of Bintaro Raya – in public space as well as in the intimacy of living rooms – illustrate the everyday ambiguity of people who appear to be trapped in their imagined middleclassness: they were 'lost in mall'.

Indonesia produces one of the widest ranges of craft products that are continually developing to expand the range of craft goods for the market. Craftspeople are responding to a growing appreciation and awareness of products that are expertly hand-crafted rather than machine-made. There is a growing recognition that it is the poorest people who are capable of using their skills to create objects of great beauty and desirability. It is craftsmanship at this level that the book seeks to encompass.

Another dimension is the analysis of Indonesian craftsmanship in relationship to the creative industry and the role that design plays. Craft has become an integral part of design thinking, and this aspect of craftsmanship in the Indonesian context has not been explored before in any systematic way.

Most literature on the economic crisis in Indonesia has focused on the negative macro-economic impacts during the "crisis-years" (1997-1999). With a longitudinal research perspective, this comparative study analyses a wide variety of responses to the crisis among communities and households. They often contradict the pessimistic assumptions of communities'/households capacities to cope with crisis conditions. Covering different areas of Indonesia, variations in resource use practices and resource use regulations define the way rural households can cope with crisis conditions and adapt to new circumstances. The studies show that coping and adaptive behaviour increasingly depends on the ways people are able to tap into supra local networks, even beyond national boundaries. However, without sound interventions, the long term perspective is one where sustainable resource use systems slowly deteriorate as local resource use regulations are overruled by processes of internationalization. The book thus may contribute to the development of more effective policies for increasing resilience among rural communities to withstand crisis conditions.

In 1999, the MPR enacted the First Amendment to the 1945 Constitution. Over each of the next three years, it passed three further amendments. Despite their important contribution to Indonesia's transition as the impact of the fall of Soeharto's regime, there has been no comprehensive study on these four amendments and the process by which they were produced. This book attempts to fill this gap, by critically evaluating the process and outcomes of these amendments in the context of constitutional theory. The book also describes the experience of other countries, in particular South Africa and Thailand, in amending their constitutions.

From Indonesia's experience, scholars should note how the symbolic value of the 1945 Constitution strongly shaped the way constitutional reform took place in the post-Soeharto era. Despite a process that was different to democratic processes in other countries, Indonesia's slow, patchy and tentative process managed to lead the country to a more democratic Constitution and contribute significantly to Indonesia's transition from overt authoritarianism to a constitutional democracy.

Based on a decade of research in Indonesia, this book provides an in-depth account of the military's struggle to adapt to the new democratic system after the downfall of Suharto's authoritarian regime in 1998. Unlike other studies of the Indonesian armed forces, which focus exclusively on internal military developments, Mietzner's study emphasizes the importance of conflicts among civilians in determining the extent of military involvement in political affairs. Analysing disputes between Indonesia's main Muslim groups, Mietzner argues that their intense rivalry between 1998 and 2004 allowed the military to extend its engagement in politics and protect its institutional interests. The stabilization of the civilian polity after 2004, in contrast, has led to an increasing marginalization of the armed forces from the power centre. Drawing broader conclusions from these events for Indonesia's ongoing process of democratic consolidation, the book shows that the future role of the armed forces in politics will largely depend on the ability of civilian leaders to maintain functioning democratic institutions and procedures.

Mixing theory with empirically based analysis, the book examines how the spectre of communism and the trauma experienced in the latter half of the 1060s remain critical in understanding the dynamics of terror, coercion and consent today. Heryanto challenges the general belief that the periodic anti-communist witch-hunts of recent Indonesian history are largely a political tool used by a powerful military elite and authoritarian government.

This book explores the political and ideological motivations behind the formation of the Nahdlatul Ulama-affiliated political party, and Abdurrahman Wahid's rise to the Presidency of Indonesia after having led NU for 15 years away from formal politics. It sheds light on the complex and historical rivalries within Islam in Indonesia, and how those relationships inform and explain political alliance and manoeuvres in contemporary Indonesia.

This is an excellent book which will have a major impact on the current debate about the relationship between Islam and politics in Indonesia. Its greatest strength is its innovative characterization of three Indonesian Muslim models of polity, as opposed to the normal two, Islamic state and secular state. Assyaukanie brilliantly delineates a third model, which he calls the Religious Democratic State, in the process greatly clarifying our understanding of the previous models, which he now proposes to label Islamic Democratic State and the Liberal Democratic State. Another strength of the book is methodological. Each of its arguments is solidly grounded in the thoughts and actions of particular players, Indonesian Muslim thinkers and activists. _____

This book examines the social changes in Indonesian cities during the process of decolonization. The political upheavals of the Japanese occupation and Indonesian revolution, and the first steps to build a sovereign nation, had major repercussions for urban society. These social changes are studied from the angle of urban space in general, and the provision of housing in particular. This focus on the everyday matter of housing, in combination with a local level of analysis, provides fresh insight into how people experienced decolonization. In the first half of the book, the author challenges the idea that a shift from ethnic to class differences was the overriding social change during decolonization and argues instead that class differences already formed the predominant dividing lines in colonial urban society. The second half of the book focuses on the shifting balance of power between the main agents in the urban arena.
