In his final book, the late historian Benito Legarda Jr tried to bring to light what makes our Spanish-era churches truly Filipino.

Distinguished economist, historian and scholar Benito Legarda Jr had devoted his writing career in promoting Filipino culture and history. He served as deputy governor of Bangko Sentral ng Pilipinas, among many others. The prolific historian focused his essays and articles on the Spanish colonial galleon trade, the Philippines's 19th-century economy and the Second World War in Manila, which he had witnessed and experienced during his teenage years.

With his passing last year at the age of 94, the Ortigas Foundation Library decided to publish his architectural study from the '60s about Hispanic Philippine churches.

Complemented with modern photographs from the Ortigas Foundation's extensive collection, *Hispanic Philippine Churches: An Architectural Study* was finally published.

The first Chapter of the Book details the first five years of the Catholic History of Pasig which stretches to 15 August 1571 which will reach 450 years a little less than a month from now — when Fray Alvarado and the conquistadores traversed the Pasig River to reach Cainta, the first among their destinations. Sometime during the conquest, Fray Alvarado was sent home early by the Captain due to the friar's old age and frail health. Fray Alvrado and some men then went from Paracale to Bay (Laguna) to Taytay to Cainta then to Pasig where, as the Conquistas says, he preached to the Moro inhabitants of the area.

The sources of these facts and a more comprehensive explanation can be found in the book, though some of the primary sources have been indicated here. This history of Pasig is yet to be known by many, and is awaiting to be known by those who purchase and read the book, especially its first chapter.

A man going through a messy annulment tries to gain the upper hand in a settlement negotiation with his estranged wife, but all he has to barter is his beloved Toyota clunker. A pregnant overseas Filipino on a plane ride home struggles to keep herself from giving birth in the lavatory, so she can give her baby up for adoption. A middle-aged woman traumatized by a childhood experience is on the verge of creating her true self as a sociopath. A shut-in plagued by mental illness holes up at his run-down residence with his handgun and prepares for the worst, when a mysterious "Utility Man" arrives at his door and offers to clean his yard for free. In the title story, three high school buddies, now in their forties with their youthful days well behind them, are in a wine bar catching up on each other's love lives and careers. Out of nowhere, a black hole appears beside their table, threatening to upend their assumptions about reality and existence. Should they engage it, even at the expense of a good time on a Friday night? By turns funny, sad, and simultaneously funny-sad, these and seven other stories of anxiety, existential dread, disconnectedness,

Most of the forty-nine works in the book were specifically solicited from the writers I know in response to the question, "What makes you tingle as a lesbian?" Literally, the sensation of "slight prickles, stings, or tremors," the excitement. I purposely didn't give any more qualifiers to that prompts. I wanted the writers themselves to define the terms and enact them on the page. And while the word "tingle" is a homonym for the Tagalog word for "clitoris," many of the pieces submitted were not about sex at all. But all the pieces are about a spark of recognition, whether at the beginning, the middle, or the end, that one loves a woman as a woman. Tingle is the flint.

Here we are taking our stories of women loving women in our own hands and making ourselves visible on our own terms. When the initial thrill of desire is past, the tingle is ultimately the recognition that what we have found cannot remain in the dark—we must love and be loved in the light.
