Dating back 5,000 years to ancient petroglyphs carved on cave walls, Angono's long artmaking tradition has produced two National Artists, numerous art galleries, and the famous Higantes Festival. The town gained renown as the "Art Capital of the Philippines" after Carlos "Botong" Francisco's modernist paintings captivated the art world. However, even a master like Botong stood on the shoulders of Angono's giants who came before him—artists like Juan Senson, Pedro Piñon, and Moises Villaluz Sr. The works of these old masters, Angono's own "triumvirate," are little acknowledged and seldom studied, apart from a few pieces which have ended up in the Bangko Sentral ng Pilipinas collection as cultural treasures.

Nineteenth-Century Masters of Angono Art endeavors to write anew the town's art history, showcasing the lives and oeuvres of these foundational artists. Author James Owen Saguinsin has

Illustrated with more than 100 artworks—most unearthed by the author and documented here for the first time—this book explores the history of Angono, the role of Senson, Piñon, and Villaluz in shaping the town into the national art center it is today, and their contribution to the Filipino

Packaged Food, Packaged Life argues that the abundant consumption of corporate brands in slums does not merely stem from individual lifestyle choices but also is the result of historical circumstances that preclude good living conditions and limit opportunities for people who resort to corporate packaged food. Drawing on his own fieldwork and exhaustive review of related literatures, Heriberto Ruiz Tafoya identifies the constraints that characterize a packaged life not as a definitive status but as an ongoing process. His perspective comes from his own experiences as urban poor in Mexico and from the eclectic amalgamation of the Latin American ethical and political approach of *buen vivir* (living well or life in fullness) and its Philippine counterpart ginhawa (vital spirit that animates our well-being).

The book is a pioneering work on packaged-food diets in the global south, serving as a reliable reference for readers interested in the retail and consumption of processed food especially by marginalized communities.

Marcos Lies is a compilation of thirty-one research essays that discuss in detail the various lies that the Marcoses have either concocted or have done nothing to stifle, lies that aided them in pursuit of power and plunder. This book shows how the lies were crafted, who enabled the Marcoses to foster their falsity on their targeted audience or those who knew the truth but have chosen to be silent. Each chapter gives details on how institutions and individuals were corrupted by the Marcoses to ensure that the lies they have made would not easily unrayel. If corruption fails, the Marcoses of the martial law years have no qualms in resorting to censorship and the silencing of contrary and critical voices. During the martial law years, the Marcoses had at their disposal the whole state apparatus for propaganda, ensuring that a Marcos lie would not only remain valorized and unchallenged but that it would be repeated in all mediums and avenues used for the dissemination of state information. Their lies were then documented. To prove the lies, the authors have relied on documentary sources, much of which remains untapped, ranging from recently digitized records in the custody of the Presidential Commission on Good Government to the mountain of Marcos apologia produced by the National Media Production Center during the 1970s up to the 1980s. Many of these underutilized sources have been digitized and have long been made freely available online by their custodians. Without access to university resources during the pandemic, the authors revisited these online archives for news reports and diplomatic cables, transcript of congressional investigations, and various fragments of data that when put together offer a clear view of the truth that the Marcoses have either hidden or twisted. A disproportionate amount of recent studies have focused more on the utilization of deception to help the Marcoses reclaim Malacanang than on their deceptiveness during the rule of Marcos Sr. This is also, unavoidably, among the concerns of this book. But in the writing of the articles comprising this volume, after being similarly animated by the fact-checking ethos of those in the media, the authors' tendency has been to ask, "How far does this lie go? Straddling transoceanic US history, while still firmly situated in Philippine studies, this book boldly incorporates global forces into the retelling of local history. The historical voices woven into its narrative are diverse—Bagobo traders, Spanish missionaries, American housewives, Filipino settlers, Japanese laborers, and so on—each of whom found themselves in the Davao region in the early twentieth century for different reasons, yet all shared some vision of its promise. It shows how in many ways, the people of the region share a similar, while at the same time different, past. It thus fosters a nuanced view of history instead of subscribing to overly broad generalizations. While general patterns can be seen, it must also be taken into account that every community responded to the transformations of the 1400s to the 1800s in their respective ways. It must also be considered that the people of the region were not mere passive receivers of change but instead, active agents in the transformation as they, both carefully and recklessly, negotiated with the new realities that they faced. The history of the region must thus be viewed on its own terms but with consideration for the broader and longer historical context.

This work brings together the works of historians from Maritime Southeast Asia that were presented at the 65th anniversary conference of the PHA and 7th Conference of the International Council for Historical and Cultural Cooperation-Southeast Asia (ICHCC-SEA). In his long and distinguished career as a medical psychiatrist, Dr. Luciano P. R. Santiago cultivated a keen understanding of the frailties and vagaries of human nature. This is a skill that he applied with equal precision to the study of Philippine culture and history—specifically the stories of liminal, transitional figures who occupied the often dimly illuminated interstices of Philippine colonial history during Spanish rule. He was most interested in transformational arcs, when individuals—by virtue of ancestry, will, or circumstance—emerged from historical obscurity to embody history-making change and self-actualization.

Dr. Santiago's approach to historiography did not focus on grand sweeping narratives nor did he attempt to interpret the zeitgeist of a particular historical moment in the context of purposive scholarship. Instead, he was an inveterate chronicler, employing the miniaturist's compulsive

attention to detail to the quotidian world of a vanished culture and the long-forgotten personages that inhabited it.

In the works of Dr. Santiago, Philippine history becomes a series of "revealed" memories, especially of seminal Filipinos whom modern readers may otherwise have not known because they were not necessarily heroes or larger-than-life figures who reversed the course of history. Instead, their lives unfolded in the obscure annotations on a family genealogy, in a baptismal document, in a marriage certificate, in the codicil to a will, in the documentation of a legal dispute, and finally, in the remembrances delivered by families or friends upon their often ordinary deaths.

This definitive reader features twenty-two of Dr. Santiago's key essays on genealogy, art history, religious history, and pioneering Filipinos. The reader is invited to reflect not just on the breadth of Dr. Santiago's scholarship, but also his particular and carefully detailed investigations into what he called the terra incognita of Philippine colonial history.

The knowledge of how women are represented in a specific advertisement to hit the target audience of the products being introduced is not only confined in a certain field of discipline and groups of people; instead it traverses to different aspects of humanity where consumerism is fundamental. Thus, this study attempted to determine the iconic representations of women and find out how these have shaped the role they portrayed in the magazine advertisements. Using the qualitative analysis particularly Ferdinand de Saussaure's semiotic theory, icons on beauty products, vehicle, food and beverage, clothing and accessories, and vitamins and food supplements were analyzed. The analysis of results revealed that the iconic representations of women in magazine ads were relative size, feminine touch or touching any object, function ranking, the family, ritualisation of subordination, licensed withdrawal, body display, feminine power and

women empowerment which come in various signifiers and signified concepts. These iconic representations shaped the roles of women portrayed in the ads which include their roles as sex object, mother/nurturer, physically attractive or decorative, working or career woman, dependent, recreational and authority.
