This book is a critical edition of an unpublished illuminated manuscript of the Poem Luc Vân Tiên rediscovered in the Library of the Académie des Inscriptions et Belles Lettres in which his author, Nguyễn Đình Chiểu (1822-1888), expounds Confucian virtues and the beauty of Southern Vietnam popular culture.

Nguyễn Đình Chiểu's poem Lục Vân Tiên has long been a celebrated literary masterpiece as it is one of the first pieces of classical literary work that integrated elements of Southern Vietnamese culture. Although the poem was translated in French as early as 1864, it is the version published by Abel des Michels in 1883 that inspired a French navy officer, Eugène Gibert, to order an illuminated manuscript from a court Lettré, Lê Đức Trach when he was based in Huê between 1895 and 1897. Back in France in 1899, Gibert offered it to the Library of the Académie des Inscriptions et Belles Lettres where it was rediscovered in 2011. This is the only integrally painted version (139 colored sheets) of a Vietnamese poem known to this day. The literary and historical value of this unique opus, led us to publish a commented fac-simile. The first volume is limited to a reproduction of illuminated sheets side by side with a trilingual translation of the poem (French, Quốc Ngữ, English). Volume II contains the commentaries (foreword, introduction to the history of the manuscript, annotations of the poem, original transcription of the illuminated manuscript into Romanized Vietnamese). Just as the Luc Vân Tiên is a masterpiece of Vietnamese poetry, this manuscript, a product French-Vietnamese contact, is also masterpiece of visual art. Following the recent rediscovery of this gem of Vietnamese popular culture it was necessary to make it available to specialists, as well as scholars

interested in history, literature, philology and art. The publication of The Story of Luc Vân Tiên made this possible.

This book contains 13 chapters covering various aspects of globalization, modernity and impacts to Asian urban to some specific cases about the livelihood and life experiences in urban of Vietnamese and Malaysia contexts. This collection is informative and would bring benefits for scholars in many fields of social sciences such as sociology, psychology, anthropology, communication studies or urban studies as well. It is constructed from papers in four main contents, as following: At first, It starts with very basic and fundamental background about the impact of globalization to the urban studies and presents the theoretical frameworks in terms of engaged research and urban changes in global perspective. These contributions would encourage

the social research on urban and related problems in Vietnam. At second one, other three papers show many cases in aspects of developing industrial zones in Vietnam also draw the transformation in the suburban or peri-urban areas which need additional and further research in order to have comprehensive views about the changes of local people life during such transformation. In the third part, researchers from Malaysia share their research work about livelihood of low income urban people by the safety network and accessibility to the community shop to help such low income urban people. That is a good example for service provision in the urban areas of the developing countries. And at the final part, five other papers in the overall topic of cultural changes in the urban of Hanoi identify the specific topic of religious, consumption and waste, television watching and changes of museum. With this final part, the edited book would present additional changes in the urban life following the impacts of globalization and modernity.

Although it is an informative book about the urban in Asian, it would be easier for readers to follow if it would be constructed into four main parts as above mentioned with headings (for example: theoretical background, transformation in peri-urban, economic changes and cultural changes), and it would include the index of keywords and authors for better presentation. In the final reviewing, it is a good reading collection for researchers who are interested in the contemporary urban changes in the globalization and modernity in general and in the specific contexts of Vietnam and Malaysia in particular.
