[This is the fascinating story of one of the most sensational trials ever in Sri Lanka. At dawn on 8<sup>th</sup> February 1965, an eleven year old boy was found dead at the bottom of a church well in Ratmalana. Amidst public clamour to avenge the boy's death, Pauline de Croos, a 20 year old convent-educated girl was arrested for murder. Her trial took 10 days in 1968. The Chief Justice who presided at the trial had to caution the Jury to protect themselves against prejudice. There was also evidence of an affair between the girl and the victim's father which turned out to be irrelevant, and the Chief Justice had to warn the Jury that she was "not being tried for that conduct". She was found guilty of the murder of the boy by a 6 to 1 verdict of the Jury and was sentenced to death. In Appeal however, one Judge had "no doubt that prejudice would have intermingled with reasoning."]

[This report does not aim to be a comprehensive synthesis of all such civil society efforts, but it discusses some key initiatives that have been undertaken by a diverse array of groups utilizing a range of different methodologies and inspired by different goals and visions of the past and future. This extended essay looks at four initiatives, the work of Kalape Api, the Citizen's commission on Border villages, the Women's Peace Mission, and the National Vision document. It looks at what these initiatives attempted to achieve, the challenges that they encountered and what their experiences say about the conditions within which human rights work in Sri Lanka is conducted.

We believe that the issues highlighted in this essay will be critical in thinking about future transitional justice initiatives in the country.
