The need for publication of the present volume was felt as there was a continuing discourses on desirable, objective law enforcement and the conduct of our police functionaries. A healthy debate had ensued on the subject in which all stakeholders were evincing a keen interest. This indeed was a welcome situation in a democratic polity.
