Does a non-core group pursue a certain pattern of collective political behavior, or does it have the ability to alter it through struggle with other groups by calculating the existing opportunities and restrictions? This book addresses these important questions by focusing on the history of political representation of the Muslim-Turkish minority in Greece and the Greek-Orthodox minority in Turkey, two communities whose rights are linked to each other via the "reciprocity principle" written in the Lausanne Treaty, signed by two countries that have long-lasting conflicts. Drawing on presentation of related political history, systematic coding of parliamentary debates and works, minority and mainstream newspapers, and elite interviews, the author analyzes and explains ignored linkages between institutions, bilateral relations between Greece and Turkey, and the role of external factors that enable or constrain minority communities' access to political life. This study which adopts a historical institutionalism approach and, by integrating theory of both comparative politics and international relations, shows how the minority groups' political participation and the effectiveness of their representation has been determined by the triangle of the two states' choice of nationalism, reciprocity and Europeanization policies, mainly argues that internal factors such as groups' capability for competition and institutional features of the political system in the host-state mostly override states' bilateral relations with the kin-state and international factors. As a result, for the Greek and Turkish case, the host-states generally pursue the policy of state-controlled involvement of their minorities in the political life, where the existence of the threatening kinstate and minority groups' strong demographic features lead to avoidance of full assimilation and exclusion from political representation.

The National League for Democracy (NLD), the ruling party, is taking a more democratic platform focusing on the creation of a democratic federal union, while the Union Solidarity and Development Party (USDP) adopts a more nationalist approach, emphasizing the prevention of foreign interference regarding Rakhine State.

Strong leaders court controversy. He had his share, both domestically and internationally. But he stuck to his resolve. History, he often said, would judge him. In October 2003, he passed the baton and réturned to civilian life.

But the Malaysia he left was not the one he had envisioned. Fifteen years after leaving office and when the situation demanded it, he returned to lead the country in the historic

May 9 General Election. He coalesced a disparate Opposition against the ruling Barisan coalition with the same vigour and panache he had displayed in his heyday. The wonder of wonders! May 9, 2018 will go down indelibly in Malaysia's history as the day a political tsunami swept aside a coalition that had ruled the nation the for six decades. Dr Mahathir had brought hope again. People celebrated the rebirth of a nation.

For many, he is the man who did the unthinkable. This book recollects the early events prior to the stunning May 9 evening and the journey of the world's oldest leader taking centre stage again to rebuild the nation battered by the recent past.
